Commissioners met with Renee Haight to discuss tax issue

Renee Haight we financed the property for some guys to improve the property. They signed it back to us and the taxes were part of when it was owned by Quilacy as part of CSI. I came to you to ask to have the taxes assigned to CSI from when they owned it. There was some sort of indication that you would remove the interest on the taxes from 2008. We never received any record of what had been done with the taxes from the June decision. I did speak with Mr. Mikesell and said that the tax change had been done and he would send a copy to me. I do understand there was a tax notice sent out but it was sent to the previous owners so we did not have any record of the taxes. I am asking for the \$23.31 of late interest to be removed since we did not receive the notice. Commissioner Urie wouldn't the tax bill go to the current owner? Renee it should go to them, but we had to take back the property and there is no way we will ever collect that from them. Commissioner Mikesell the burden is not on the county if you did not receive the notice. It has been upheld in court. I understand your concern but the burden is on the property owner to pay the taxes. Renee we only financed it. At the time these other people financed it there was no tax owed. Commissioner Mikesell but you still own the property and the burden of the taxes are still on the legal owner. We did take off from when the college owned it, but I would not vote to forgive the fees. It is the burden of the

property owner to pay the taxes. Commissioner Urie these fees are from after CSI owned it, when the person you financed owned it, correct? Commissioner Mikesell yes, we took care of the taxes and late fee from when CSI owned it. Commissioner Kramer I would like to see a written request from Renee so we can consider it as we normally do. Commissioner Urie what is the status of the property at this time? Renee, we received the tax notice for this year.

Commissioner Kramer made a MOTION to take this information under advisement and require a written request and then will put on the agenda for formal consideration. Commissioner Mikesell SECONDED. Motion Passed.

In the Matter of PLATS

Commissioners considered final plat for Shoshone Heights Subdivision 1& 2.

Commissioner Mikesell made a MOTION to table the final plat for Shoshone Heights Subdivision 1&2 pending further review. Commissioner Kramer SECONDED. Discussion Commissioner Mikesell we just received the paperwork on this plat this morning and have not had adequate time to review the paperwork. Motion Passed.

Commissioners considered conveyance plat for Kimpton Acres Subdivision

Renee Caraway, City Zoning and Development, this is a conveyance plat for Kimpton Acres Subdivision which has 2 lots on 7.47 acres. It is within the city's area of impact. The owners of the property would like to split off part and sell one of the houses to a family member. Because this property is not able to be developed, they have chosen to go through a conveyance plat process. The owners are aware of the process that they need to follow if they want to further develop the property. The city has recommended approval subject to 2 conditions. One, subject to final technical review and two, subject to easements and right of way as shown on the plat. Our staff does concur with the city's recommendations.

Commissioner Mikesell made a MOTION to approve the conveyance plat for Kimpton Acres Subdivision subject to the two conditions recommended by the city. Commissioner Kramer SECONDED. Motion Passed.

Commissioners considered extension of approval of final plat for Desert Falls Subdivision.

Renee Carraway, City Zoning and Development, this is a request for a 2nd 1 year extension of the final plat for Desert Falls Subdivision. In November 2007 the city council recommended approval subject to 3 conditions. There was a request for 1 year extension in 2008; it was approved with the same 3 conditions. There is another request for a 2nd extension of the development of this plat. The city council has recommended an extension of this plat. Due to economic conditions the developer is putting off improvement. Commissioner Urie how many extensions are allowed? Is there a limit? Renee, no. Not at this time. Commissioner Kramer have any requirements changed in

the last 3 years for other new developments coming in? Renee, the impact fees on development have changed. Commissioner Mikesell if we have a condition of technical review to make sure they are in compliance with changes would that catch those changes? Renee if it is felt there have been significant changes, then it is appropriate to deny the extension. Commissioner Kramer the city thinks it is OK? Renee, they believe there have not been significant changes to affect this plat.

Commissioner Mikesell made a MOTION to approve the extension for 1 year subject to conditions. Commissioner Kramer SECONDED. Motion Passed.

In the Matter of PEST ABATEMENT

Kirk Tubbs Pest Abatement District Manager presented annual report.

Kirk Tubbs, Pest Abatement district Manager, I submitted the report and so if you have any questions, I would be glad to answer them. Commissioner Urie are you dealing with anything other than mosquitoes and black fly right now such as grasshoppers or crickets? Kirk Tubbs, the black fly and mosquito's kept us pretty busy this year so for now we have not dealt with grasshoppers or crickets. Right now with the staff and equipment we have, we would not be able to respond to a large scale grasshopper or cricket issue. We are watching but those are generally dealt with by aerial means which we don't have. Commissioner Mikesell we have other issues we are dealing with that we have to attend to. We just want to make sure we are in the loop. Commissioner Urie there was some talk of expanding the area into the Buhl or Clear lakes area. Have you gone there? Kirk Tubbs, we gave them costs and have not heard back from them. We want to make sure that it would not come at the cost of Twin Falls County. Commissioner Urie do you have the ability to contract out to an area without them being part of the district? Kirk the statute allows us to go outside the district if it would affect our area and with the fly's they do come over to our area. Commissioner Kramer the building seems to be working for you. What are your long term goals? Kirk Tubbs, it is working well, we would like something a little better sealed. John Snelling, Pest Abatement District Board Chairman at this time there is not a lab area where we could do grow outs, some cultures. And with the temperature control and dust issue's it is not feasible at this time. We have looked at a pre-fab lab, so it could be moved if we needed to change locations. We are leasing and at this point with the budget, I don't think we will be in a position to buy property for a while. I am not entirely sure purchasing a building is the best option right now anyway. Commissioner Mikesell I did not get any complaints that you guys were out there so that

is a good thing. Kirk Tubbs, we were very aggressive on getting the Mosquito larvae and black flies treated early. Once we started using BTI, we were able to keep control of it. Commissioner Kramer I don't know if it was the year or the program, but I did not have the problems out at my house at all. So that was great. Kirk Tubbs, we had 3 traps test positive for West Nile, we treated those areas and did not get another positive test. Kirk went and met with officials in Boise and it was interesting on the report back that we were taking an early approach to dealing with the issue. Other area's treat for the adults. We would rather control the larva upfront rather than exposing people to insecticides and it is better to be proactive than reactive. Commissioner Urie what kind of response are you getting from contractors that are building the control ponds? Kirk I have met with city officials and most contractors are agreeable and it seems to be working well. We treat the ponds early in the year and we only have to treat once. Commissioner Mikesell has the city be responsive to your designs? Kirk Tubbs, they have been receptive. Commissioner Mikesell we have an annual builders meeting and maybe you could do a presentation at that. Contact Rick Dunn at Planning and Zoning. John Snelling Other things we have done are met with some other departments such as the Health District and South Central Community Action to get information out on the program. Kirk Tubbs we were at the Fair and it was amazing the response we got. It helped us find other area's that needed treatment. We want to do more PSR's and we have a website. John Snelling our meeting notices are posted, our minutes, that sort of thing we want to communicate what we are doing. Kirk Tubbs the products we use are posted so the public can see the information on it. I want to educate people on their designs that will help. John Snelling homeowners can use some of the safe pesticides; we want to get that information out there. I have been very pleased with the efficiency Kirk has shown with getting the treatments out there. We are treating more effectively, faster and cheaper and the safety aspect is much better. Commissioner Kramer with the canal districts controlling the moss better, has that helped? Kirk Tubbs it has helped some. Certain sections of the canal produce more black fly and we are mapping those areas and are still working on gathering the data. Commissioner Kramer so you laid off your helper for the winter? Kirk yes and we don't know if she will be back. John Snelling we are looking into a grad student option. We would like to gather more information on the migration of the black fly and we just don't know enough. Commissioner Kramer isn't there a national meeting on the black fly issue? Kirk Tubbs, I am going to attend a meeting in February. The west canal system is unique compared to other area's that deal with the river. John Snelling I have an update on the lawsuit on the discharge into waters. Thus far we have been under the radar because for the most part, we were formed after that lawsuit has been filed. As the permit becomes available through the EPA, we will be filing for that. In the past abatement districts were exempt. Commissioner Urie you guys are doing an excellent job. Thank you for your work.
