WHEREAS, discrimination on the basis of race, color, religion, gender or national origin in the sale, rental, leasing or financing of housing or land to be used for the construction of housing or in the provision of brokerage services is prohibited by Title VIII of the 1968 Civil Rights Act (Federal Fair Housing Law); and

WHEREAS, it is the policy of Twin Falls County to encourage equal opportunity in housing for all persons regardless of race, color, religion, gender or national origin; and

WHEREAS, the Fair Housing Amendments Act of 1988 expands coverage to include disabled persons and families with children; and

THEREFORE BE IT RESOLVED, that within available resources, Twin Falls County will assist all persons who feel they have been discriminated against because of race, color, religion, gender, national origin, disability or familial status to seek equity under federal and state laws by referring them to the U.S. Department of Housing and Urban Development, Office of Fair Housing and Equal Opportunity, Compliance Division.

THEREFORE BE IT ALSO RESOLVED, that Twin Falls County shall publicize this Resolution and through this publicity shall encourage owners of real estate, developers and builders to become aware of their respective responsibilities and rights under the Federal Fair Housing Law and amendments and any applicable state or local laws or ordinances.

THEREFORE BE IT FURTHER RESOLVED, that Twin Falls County will 1) publicize this resolution; 2) post applicable fair housing information in prominent public areas; 3) provide fair housing information to the public; 4) prepare a fair housing impediments analysis; and 5) declare April as Fair Housing Month.

Ken Fitzgerald, citizen of Murtaugh, I moved to this area with plans of settling here permanently. I have family in this area and brought my business to the area. A few years ago, we split some ground with the intent of building my home on it. The ground has been farmed for many years, but we have had to bring in dirt to continue farming it in order to not lose the water rights. We started building 2 years ago and were told we had to stop construction. The permits were approved 6 years prior and now we are being told something different. No one knew we could not split the ground twice. I was told several times by several county employees including the Clerk's office. I have been getting conflicting reports on what the process is. I have requested a hearing and was refused. I do not want to take legal action. I am asking for some help to get this accomplished. I built a guesthouse and now want to build my main house. The guest house was never intended to be the main house. I have employed several contractors and put a lot of money into the economy in Murtaugh. I was told to build a breezeway, so I agreed so we could get this process done. My contractor told Mr. Dunn that the breezeway was the last thing that could be built. Because of this, I can not use the existing driveway and can not get another. All of this is either through incompetence, misinformation or a badly run P&Z department. I need help. I have heard from others who have had these same issues. I do not want to take legal action.

Commissioner Urie, I see a lot of contradiction in your statement about the farm ground. If you were allowed a hearing, and were told the process was upheld, what would you do? Mr. Fitzgerald, I would build the breezeway.

Commissioner Kramer we are in the process of working on our zoning ordinances and there has been a history of conflicts on our zoning and I would encourage you to participate in that process. We have to equally deal with the existing ordinances as they are today. We have to comply with them as they are written.

Mr. Fitzgerald, I support that totally. I have seen that in California and I understand the zoning requirements. The problem is that they are so vague right now that decisions differ based on the zoning departments interpretation. I have not seen any code that substantiates their decisions. They tell you one thing and then later tell you something different and there is no recourse. I had contractors lined up and now I have to put them off.

Rick Dunn, the only comment I have is his terminology. The framing has to be done first to get the inspections done.

Commissioner Kramer we have to remember that recording something does not give the authorization to build something on it. There is a different set of rules.

Mr. Fitzgerald that is my problem, the County Recorders office is getting and giving incorrect information. There is no communication between the departments.

Commissioner Mikesell, land divisions and building permits have nothing to do with each other. I understand your frustration, but you have certain requirements to get a permit to build in an ag zone.

Commissioner Urie, if we allow exceptions from what the zoning department has told you, we would have every permit that comes before P&Z come before us. We have to support the Zoning Department.

In the Matter of ZONING

Ray Coats, I am a volunteer with the Boy Scouts and we have been trying to build a camp out at Murtaugh Lake. Apparently we have violated some zoning issues and we would ask the Commissioners for relief of those violations. We were under the understanding that as long as we were doing things with no power or water, we did not really need a permit. 10 years ago we added a climbing tower and a restroom. This year we added a Yurt and the zoning people said we needed a permit and asked where the permits were for the other buildings. We are volunteers and when we tried to get the permits, there were some misunderstandings and now it is over \$1300.00 in fines and stuff and we were told the only thing we could do is ask you for some assistance. We do not have the \$1300.00.

Rick Dunn, Zoning Director the fine is \$463.78, the rest is for the permit.

Ray Coats, we did not realize when we bought the Yurt, it had plans for a cement slab or redwood which was very expensive. To save money, we did the concrete.

Commissioner Kramer, does it have water or power? Why it is so expensive?

Rick Dunn, there is no power or water but the use increases the cost of the permit. We have to inspect it to determine if they have concrete which is easily verified. We don't inspect until we have a permit and they have not purchased that. We still have the issue with the tower. There has to be a permit for public occupancy.

Commissioner Mikesell, I have no problems with waving permit fees for an agency like this but we have to make sure the process is completed correctly. Commissioner Urie, like Commissioner Mikesell said, we can waive permit fees, but not permits. They need to be issued correctly. I would like to figure out a way that would be equitable for everyone. Commissioner Mikesell, I think before we figure out an amount, we need to get totals. Commissioner Kramer, I think we should get the Yurt settled so they can get that completed. The others, we can work on those at a later date.

The Board of County Commissioners reconvened at 8:00 a.m. in regular session, pursuant to the recess of 25 February.

PRESENT: Commissioner George Urie, Commissioner Tom Mikesell and Commissioner Terry Kramer.

ABSENT: None.

STAFF: Deputy Clerk Shannon Carter.

The following proceedings were held to wit:

In the Matter of PARKS

Commissioners conducted public hearing for fee increase resolution.

Commissioner Urie opened the public hearing for a fee increase resolution for park fees and planning and zoning issues.

Commissioner Urie set a time limit of 5 minutes for each person's comments

Commissioner Urie read a letter against the RV park fee increase due to the economy from Bill and Sherry Price, Twin Falls, ID

Kali Sherril as a citizen of Twin Falls County, Murtaugh, ID. Kali reported she uses Murtaugh Park a lot and she feels like the only way to upkeep the park is to increase user fees. She supported the increase.

Jeff Leadom, Paul, ID asked questions as to what the increase included, Commissioner Urie noted only the increase would be discussed. Mr. Leadom was opposed to the increase. He spent 60 days out there last year and is against the increase. The amenities have never been improved. Other parks offer much better amenities and Murtaugh Lake does not offer those. RV users are paying the cost for use. The increase is too much. He put together a petition of regular users and asked the petition of approximately 150 signatures be considered. The increase will lose those users. A petition from the local businesses was also submitted. He opposed the increase

Troy Vetech, Twin Falls is opposed to the increase due to the amount of amenities available. The parks department does a good job, but he would like to see amenities added. This is a local user park and is a great attraction to our communities. It is not out of town people, mostly locals. The amount of increase is too much. He opposed the increase

Rod McCoy, Buhl, ID opposed increasing rates overall, but due to the needs for the park, user fees need to be increased. This would allow the park to be improved. He supported the fee increase.

Mark Alexander, Filer, ID Costs have increased and so has the County's costs. It costs more to maintain these facilities and these services have to come from somewhere. He supported the increase

Sondra Dean, Hazelton, ID I understand the need to increase the rates, do not like it, but Murtaugh lake is becoming a place that is separated by restrictions like where and when to park. These things do not happen at other parks. People go early to get parking spots. It should not be where one person has to have specific spots. When family comes from out of town, they cannot get a reserved park space next to us. Raising fees is understandable, but the amenities need to be improved.

Commissioner Urie, we are talking about the fee's right now, that would be a policy issue and you are welcome to attend any of the parks board meetings to discuss that issue.

Ted Bean, Hazelton ID This is my 51st year at Murtaugh lake and I took a drop in wages this year and because of this increase, I may not be able to make this my 51st year. I have been coming there for years. He was opposed to the increase

Rocky Matthews, Murtaugh we own property by Murtaugh Lake. I stopped taking my boat to Murtaugh Lake because it was over used. I feel that as a county tax payer, my taxes are going to support Murtaugh Lake because it is being over used by out of county users. Their taxes do not support it, there is no launch fee and so these fee's are not out of line. He supported the increase.

Rick Novacek, Parks and Waterways Director, Twin Falls County, we came about the fee increase by looking at users and all throughout the state, user fees are charged. We are competing against private RV parks and we are way under their price. Is that fair to them, they are paying taxes and the County is under cutting them. In order for us to improve the infrastructure of this lake, we have to fund it. You can go to a private R.V. space and you cant launch a boat, you can't take a walk, etc. Other sites do not offer the recreation opportunities that Murtaugh Lake offers. RV grants still have to have a match so the money has to come from somewhere. We have changed the Reservation policy and you are welcome to come into the Parks Dept. to get information on this.

Kim Leedom, Paul, ID we keep hearing that we have to increase the fee's to maintain the park, and I need to know if you raise it, and your amount of campers go down, are they still going to go out and mow the lawn and dump the trash? They are going to do that whether they are there or not. The day users are not paying to use the park at all. I think the increase is too high. A small increase is fine, but this is too much. She opposed the increase

Commissioner Mikesell, user fees are an essential part of our fees. If we don't have fees, there is not enough money to mow the lawns and then the parks are closed. So we have to have revenue to run the parks, tax dollars do not cover it.

Commissioner Mikesell made a motion to approve Resolution 2010-005. Commissioner Kramer seconded. Discussion Commissioner Kramer I would encourage you to talk to the Parks Department to verify that there are improvements happening that need to be paid for. Commissioner Mikesell we are trying to improve this facility and looking for resources. It is a challenge. Motion Passed.

RESOLUTION 2010-005

WHEREAS, pursuant to Idaho Code §31-870 a Board of County Commissioners may impose and collect fees for those services provided by the County which would otherwise be funded by ad valorem tax revenues and the fees collected pursuant thereto shall be reasonably related to, but shall not exceed the actual cost of the service being rendered; and

WHEREAS, the proposed fee increase(s) are required to offset the costs associated with providing the service(s); and

WHEREAS, the Board of County Commissioners held a public hearing on February 26, 2010, as published in the *Times News* on February 11, 2010, and February 18, 2010; and

WHEREAS, pursuant to public notice the Commissioners held a public hearing on the proposed increases on February 26, 2010;
