Amy Scott representing the Castleford Concerned Residents spoke before the Commissioners against the zoning change. They requested the county consider several positions including violations of the setbacks and notification requirements that were not considered by the P&Z department when the change was requested.

John Lothspeich represented John Schilder in the application. Mr. Lothspeich presented that the P&Z department was correct in their decision to grant the zoning change. They have completed the application and there were no violations of the setbacks. The applicant has met all requirements and there was no glossing over on the decision to approve the application. Mr. Lothspeich noted several court decisions and Idaho Code that backed the respondent's position that the decision was appropriate. Mr. Lothspeich requested the board affirm the P&Z board's decision.

Rick Dunn, Planning and Zoning Director had no further information to add.

Matt Pember asked Rick about the special permit that was noted; per Rick it was not necessary. Mr. Pember asked about depreciation of neighboring properties. Per Mr. Dunn, there is no documentation that depreciation has been an issue. Mr. Pember also asked about setbacks and approvals if all were done correctly. Mr. Dunn confirmed that the siting report was completed. Commissioner Urie asked is any changes that were not on the original plan could be made, per Mr. Dunn, they would not be allowed.

Jamie Runyon, the setbacks that are to my house are supposed to be at least 300 feet away from my property. According to what I can see, they are closer than that.

Commissioner Mikesell, Mr. Dunn can you answer that? Mr. Dunn if they are existing setbacks we will not require them to change that. Mr. Mikesell the existing setbacks are grandfathered in, is that correct? Mr. Dunn yes.
