Commissioners met with St. Luke's officials and Mustard tree officials to discuss property sublease.

St Luke's supports Mustard Tree and is trying to help the project and we have identified a space opportunity in the short term future that we would like to make available to the Mustard Tree. We are hopeful it would turn into a long term situation. We would like to discuss that space with you today. That space identified is the space on Shoup that has been vacated by Dr. Mishak. It does have potential to be permanent. It is currently known as the Dr.'s Park. The entire facility would be vacant, other than southern Idaho Learning and the orthopedic office. The facility could be available in 30 to 60 days. Commissioner Kramer would we be responsible for the upkeep? Hospital, we would be happy to maintain it until we transition to our new facility then it would be turned over to the county along with the main facility. Commissioner Kramer I would prefer that we negotiate a separate agreement with the Mustard tree depending on our need at the time of the transition. It is not our intention to move them, but we would have to consider utilities and such. I think this is a good opportunity to serve the public with a county building. Commissioner Mikesell this helps the county by freeing up the ER and serving the indigent population and I can not count the savings to the county. We have to thank the volunteers that serve this facility. Commissioner Urie I am not against this at all, but everyone else has as much claim to the property and we have to look at what best serves the county. Hospital, would this be something you would support because I know how difficult it is to make a change and we would like to see long term support for this.

Commissioner Kramer we need to see some figures over time and the maintenance issues and evaluate the cost to the county when the transition takes place. Commissioner Urie it depends on the interest in the other facility and if this building would affect a potential client we have to consider that at that time. So we can not guarantee anything at this time. Commissioner Kramer part of the plan is the main campus and we don't know if the Mustard Tree would be part of the plan for the main facility and have to consider that in the future plans for the entire facility. We will work with you to make sure you are protected and this is a great location for the Mustard Tree. Hospital, we will have a letter drafted of our intentions and everyone's responsibility. The Mustard Tree will work with the hospital. Commissioner Kramer this is a perfect facility for the Mustard Tree, large enough to accommodate future growth. Commissioner Urie so we are in agreement that this will move forward? Commissioner Mikesell I think this is something we should proceed with. It is essential for our citizens. Commissioner Urie this is a way for us to support this program without cash.
