Tim Vawser with EHM Engineers spoke on behalf of Brian Dey in favor of the Zoning change.

Bob Templeman, Filer Mayor spoke in favor of the Zoning change. Mayor Templeman noted the easement would show on the deed of both the golf course and property owner. This is unique in a golf course; this offers more opportunity to sell property around the golf course. Commissioner Mills asked if there ever would be an opportunity to vacate the easement. Mayor Templeman could not answer that question. Tim Vawser with EHM noted it would have to go through a public hearing process and it is quite a lengthy process. Commissioner Urie asked Mr. Vawser if it would be better to put the easement on the Golf Course property instead of each individual property. EHM noted it would be easier than encumbering each property. However it would limit a new owner if Mr. Dey was ever to sell the property.

Brian Dey advised that he would not have an issue encumbering the golf course property instead of the individual properties.

Merl Egbert from the Health District spoke and noted he would like the entire golf course encumbered rather than the individual properties. The Ordinance does need to be changed regarding the technical manual; it should reference the correct policy which is approved by the Health District. This is a good policy that needs the enforcement of an ordinance behind it.

Commissioner Kramer asked Mayor Templeman questions about the lot lines. Mayor Templeman explained the Ordinance's intention relating to the golf course properties only. Commissioner Kramer noted that the Ordinance did not make that clear. Commissioner Urie asked why the development was not a PUD. Tim Vawser explained the PUD process and why they were not using it for the property in question. Commissioner Mills questioned the sharing of the sewer system. Tim Vawser noted they would be separate and would be reviewed by the Health District. Brian Dey explained the reasoning behind not forming the PUD when the Golf Course was originally formed.

Commissioner Urie closed the public hearing at 10:33 a.m.

In the Matter of PUBLIC HEARING

Commissioners conducted public hearing to consider a change to the City of Twin Falls Area of Impact Ordinance.

Commissioner Urie opened the public hearing at 10:00 a.m.

Renee Carraway, City of Twin Falls Planning and Zoning Administrator, explained the change requested by the City of Twin Falls, Ms. Carraway referenced a map showing the area to be changed, the open space zone. There is a substantial area in the Open Space Zone that is in the Area of Impact and thus needs Commissioner approval to change. The request is to allow by special use permit a zip line in the open space zone and to define what a zip line is. The City P&Z Board approved the application and the City of Twin Falls Council approved the application. Commissioner Urie read the requested changes specified in the Ordinance. Commissioner Urie noted that only the Ordinance change would be dealt with in the hearing and not a site specific issue.

John Lezamiz spoke against the request to add the zip line definition to the allowed uses in the open spaces area. He noted the biggest area impacted by the change would be the Snake River Canyon and the County should protect that area. A zip line was an amusement ride. The area should be preserved and protected which is not consistent with amusement rides. Mr. Lezamiz also spoke against the economic development argument because the zip line is not the type of economic development that would help the economy. It would only employ a small group of people and is not worthwhile. This debate has been going on for 3 years. The canyon roadway will not support the type of traffic, nor parking and the taxpayer would be picking up the cost to maintain or upgrade the roadway. The cost to the taxpayer outweighs any economic development benefit. Mr. Lezamiz noted that the Commissioners options were to approve the application, deny the application or send it back to do the necessary studies to determine the costs.

Shawn Barrigar, President of Twin Falls Chamber of Commerce spoke in favor of the change. He addressed the previous economic concerns of Mr. Lezamiz and noted that the zip line industry is a boom for outdoor recreation and promotes visitors to the area. The proposed definition allows for further review through the special use permit.

Jody Tatum, Magic Valley Flight Simulation spoke in favor of the change and gave a presentation that was presented to the City Council. She believes the Open Spaces Areas in Twin Falls County are the perfect places to have zip lines. She noted the different uses of zip lines, and noted they are not mainly for amusement. The definition of zip line has been written specifically for the Twin Falls area, and she read the definition. This area has been designated as an extreme sports area and the zip line would enhance that. The special use permit process would protect neighbors and make sure it would be a benefit to the community.

David Mead spoke against putting a zip line in the canyon. He noted issues with traffic in the area. Mr. Mead gave the Commissioners a map that the Times News posted of what the Canyon would look like in year 2000 and beyond. The map was congested with commercial properties. Mr. Mead feels like the zip line has no place in the Canyon and the door to development in the canyon should not be opened.

Bill Knopp spoke in favor of the zip line. He noted the map given by Mr. Mead was a satirical opinion printed years ago. Mr. Knopp noted that the canyon is a draw to visitors and has uses that are not sacred, such as a waste water treatment plant. A zip line has a potential to attract more people to the area. Mr. Knopp noted that birds are not affected by the zip line and it would be a benefit to the community.

Katie Breckenridge spoke against the zip line, addressing concerns of access into the canyon. Ms. Breckenridge also addressed safety issues regarding the road down into the canyon. She referenced a study noting a stability concern with the canyon road. Ms. Breckenridge noted the city quitclaimed the canyon wall to their family and their family should be included in the consideration.

Chris Satterwhite spoke in favor of the Ordinance change. Ms. Satterwhite noted that opening up the canyon to a zip line would allow other sites to be considered and would benefit other businesses in the area.

Boyd Satterwhite spoke in favor of the Ordinance change and noted the applicant had worked very hard to follow the law and negative issues were being focused on instead of positive potential. Mr. Satterwhite noted there were feelings on both sides of the issue and the Commissioners should follow what the community wants and needs.

Barbara Beck spoke against the Ordinance change. She requested the canyon be considered separately from the surrounding areas. She noted the road concerns into the canyon and lack of infrastructure in the canyon. She expressed concerns of overbuilding in the canyon and asked that the canyon be preserved.

Dr. Jerry Beck spoke against the Ordinance change. Dr. Beck noted he is not against the specific zip line but the canyon should not be the place and asked for a moratorium on development in the canyon. Dr. Beck cited lack of infrastructure and road concerns and expressed the long term effects of the canyon development.

Commissioner Urie closed the public hearing at 10:45 a.m.
