WHEREAS, the Board of County Commissioners of Twin Falls County has determined that it is necessary to establish standards in order to preserve and protect such irrigation drainage facilities as identified by Twin Falls Canal Company maps and agreements on record,

NOW, THEREFORE, BE IT RESOLVED that the Board of Twin Falls County Commissioners, Idaho, adopts as follows:

Setbacks and general requirements to protect irrigation drainage tiles, wells and tunnels herein referred to as facilities:

1. Structures, as defined in the Twin Falls County Code or the building code, shall be constructed at least fifteen (15) feet from the facilities.
2. Shall not be located in the road right of way easement, except for road crossings which must be designed and constructed in such a manner as to prevent damage to facilities.
3. Lagoons or storm water runoff containment shall be located fifty (50) feet from the toe of the bank to the facilities.
4. It is the responsibility of the property owner to locate and mark the locations of any drainage tiles, wells or tunnels and show compliance with these standards.
5. Additional distance may be required upon recommendation by the Twin Falls Canal Company, local Highway District or other agency with jurisdiction.
6. Subdivisions or other developments may require a hydrological analysis and mitigation plan prepared by a Profession Engineer licensed in the State of Idaho.

Effective Date: This Resolution shall be effective upon passage as provided by law.

A RESOLUTION ESTABLISHING ADDRESSING STANDARDS FOR TWIN FALLS, COUNTY.

WHEREAS, the Board of County Commissioners of Twin Falls County, Idaho, deems it necessary to protect and promote the public health, safety and community welfare of Twin Falls County.

WHEREAS, the Board of County Commissioners of Twin Falls County have adopted County Code providing for the addressing of commercial and residential properties.

WHEREAS, the Board finds it necessary to establish standards to correctly locate and identify properties located within Twin Falls County jurisdiction.

NOW, THEREFORE, BE IT RESOLVED by the Board of Twin Falls County Commissioners, Idaho, adopts the following:

TWIN FALLS COUNTY ADDRESSING STANDARDS

Twin Falls County rural addressing originates from the southwest corner of Twin Falls County, the grid system extends North and East with road numbers increasing by 100 for each mile away from the origin. Following the road number is the direction. The road number and direction constitute the road name. For example, 500 East runs North and South and is five miles East of the Southwest corner of Twin Falls County.

Structures with even numbers are located on the North side of East-West running roads, and East side of North-South running roads. Alternately, structures with odd numbers are located on the South side of East-West running roads, and West side of North-South running roads.

The Addressing System

Twin Falls County uses the Grid System, as stated in Twin Fall County Code Title 7 Chapter 2, with regards to addressing. All frontage roads will be given a grid address number, and U.S. Highway and State Highway addresses will be based on milepost numbers. Addresses are assigned beginning at the South or West corner of the section and measuring North or East to the structure. Numbering should begin at the West beginning point of each section and proceed Eastward or at the South beginning point of each section and proceed Northward.

Typical address items include: structure number, directional, and grid road names. Example: 4014 North (structure number) 3000 East, (grid road name). The distance is divided by 5280 feet (one mile), and rounded to an odd or even number depending on which side of the road it is located. Assign numbers every 52.8 feet or each 1/100 of a mile. This will yield 100 numbers per mile, 50 even on the North and East, and 50 odd on the South and West. Numbering should begin at the West beginning point on each section and proceed eastward or at the South beginning point of each section and proceed northward.

Example: measuring North from the SW intersection of 3000 East and 4000 North to a structure on the East side of the road 3500 feet. $3500' \div 5280 = .6628$ address is 4066 North 3000 East. **See Figure No. 1**

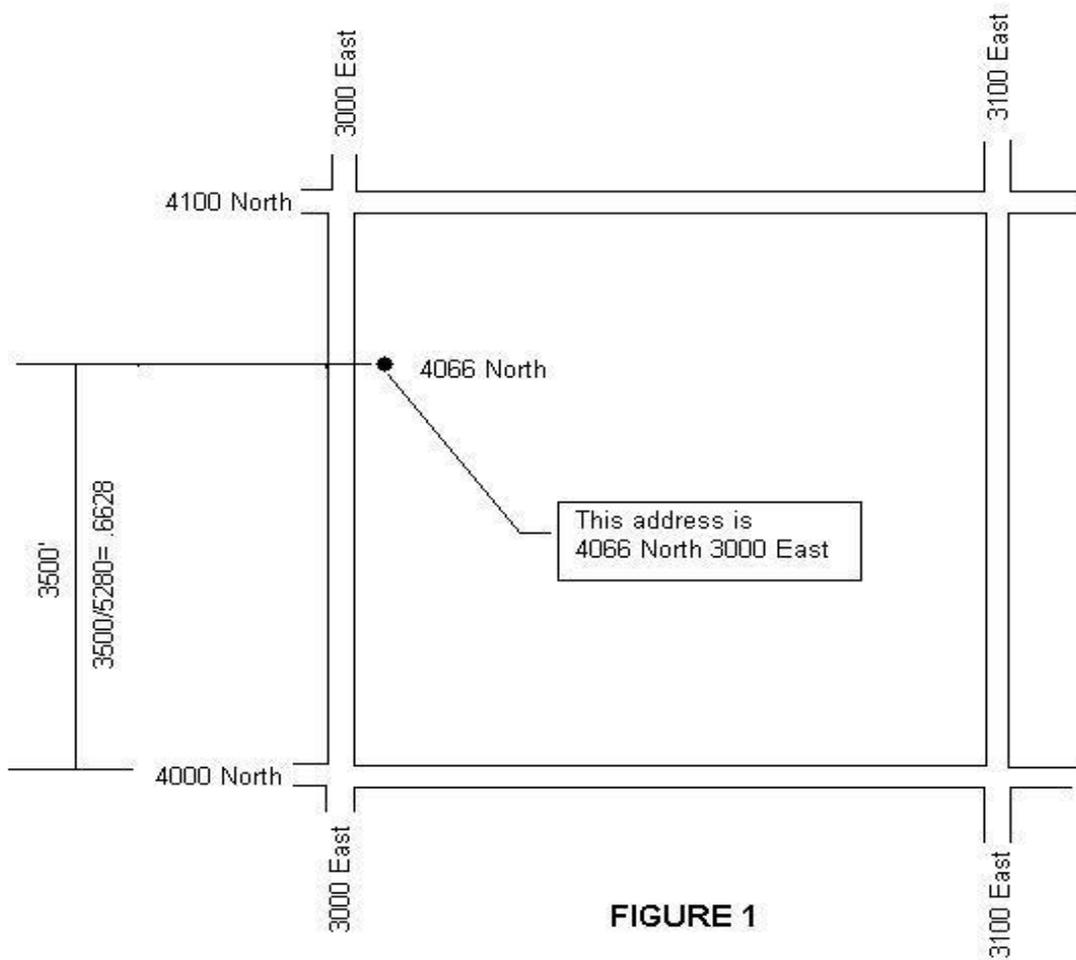

Certain rules and guidelines need to be followed with regards to Diagonal, Circular streets, Cul-de-sacs, stacked address, apartments and duplexes.

Diagonal Streets

Diagonal streets should be treated as either North-South or East-West streets. The primary direction the street runs should be chosen. To determine the way a street predominately runs, measure east from the grid intersection to the street intersection, then measure North from the grid intersection to the street intersection, which ever measurement is larger, is the direction the street predominately runs and is the way the street is named. **See Figure No. 2**

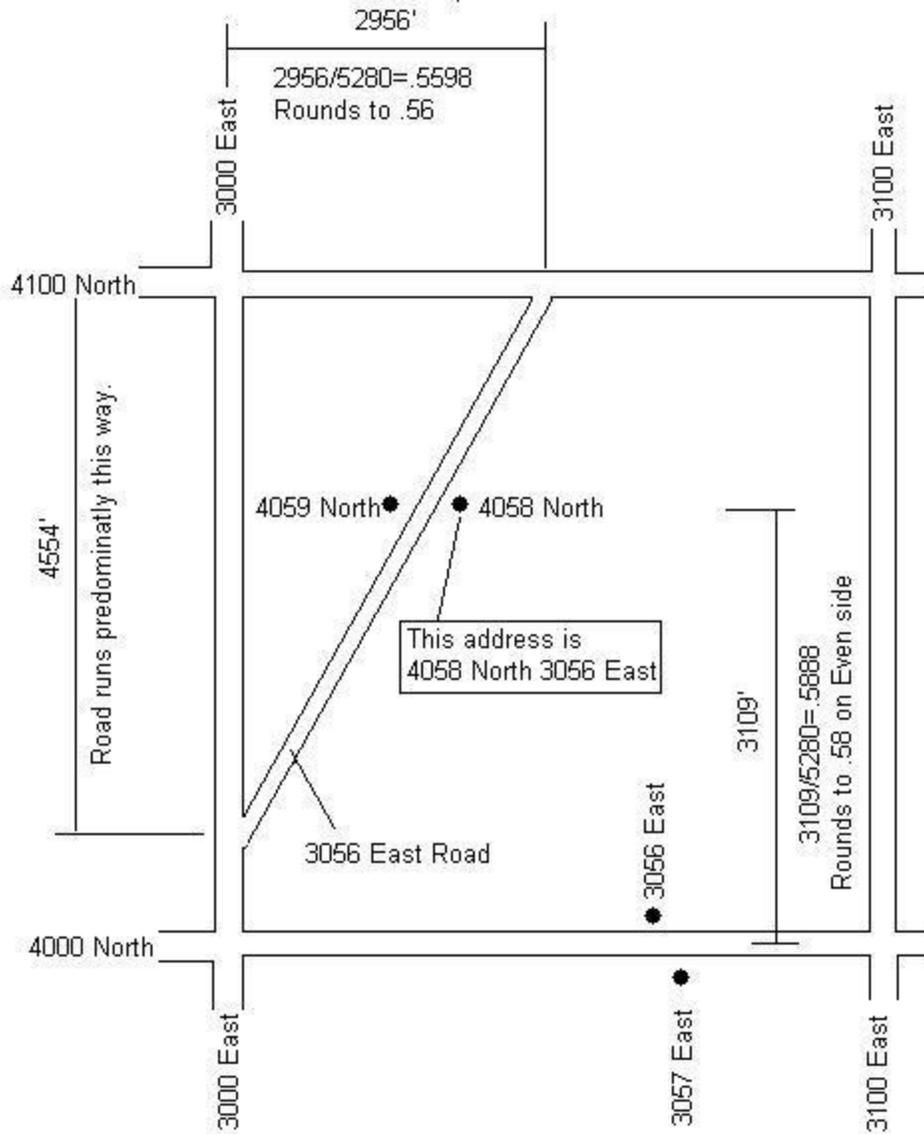

Circular Streets

Circular streets and roads begin and are named from the low numbered intersection. Structure numbers are assigned according to the predominate direction of the street proceeding from the low numbered intersection. Even numbers begin on the North and East side of the street. The outside of the circle is numbered first according to the distance between structures or lots. The inside is then numbered to match and mix with the outside. This will result, in some cases, in fewer numbers on the inside of the circle, and also with spaces between the numbers. **See Figure No. 3**

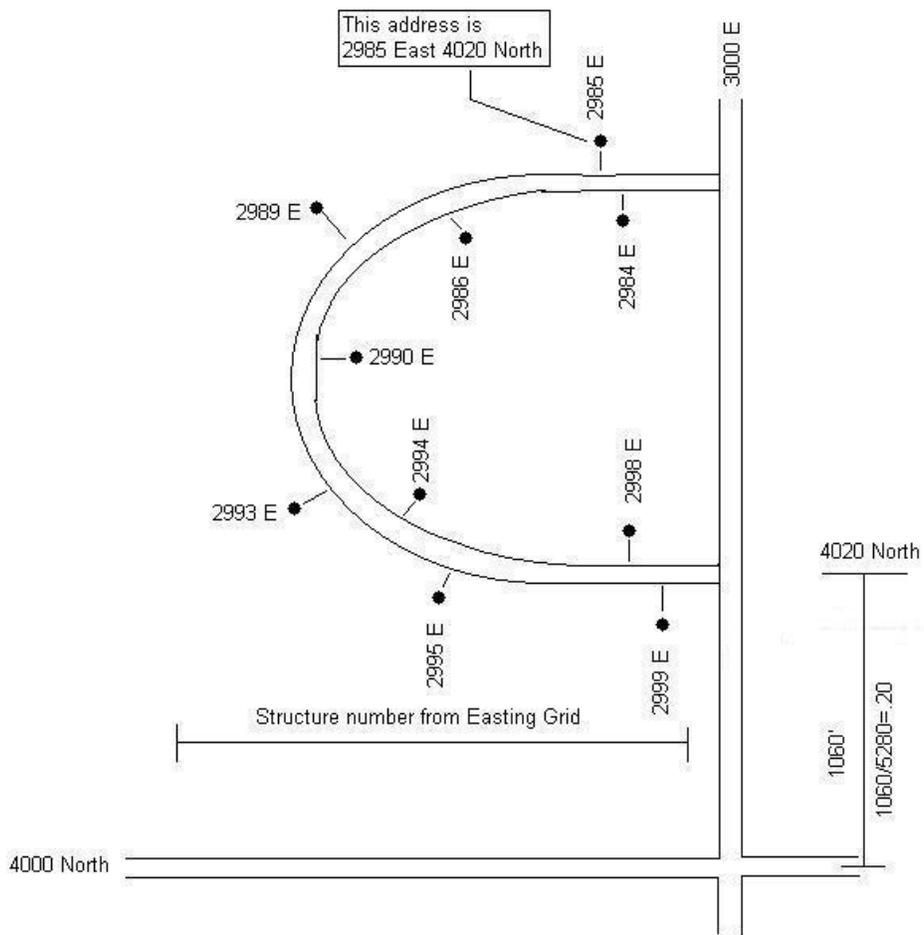

Cul-de-sacs

Cul-de-sacs often require applying rules for both dead-end and circular streets. The structure numbering begins from the intersection and increases or decreases with the sequence of the grid. Once in the cul-de-sac, the numbers proceed even around the top of the circle and odd around the bottom of the circle. See **Figure No. 4**

Businesses should be numbered just as apartments, with the middle of the building determining the address and the offices or businesses in the building being numbered as suites. This rule may also apply to “office parks” where each business has its own small building.

Interfacing with Existing Systems

When interfacing with existing numbering systems, care should be taken in locating the last assigned number of the existing systems. All possible sources should be checked to determine the last number.

Trailer Parks

Trailer parks should be numbered just like apartments. The difference would be that trailer parks will be designated as lots or trailer instead of apartments. The full address of a trailer in a trailer park would be 3210 East 4350 North Lot 12 or 3210 East 4350 North Trlr 12.

Highways

Highway addresses are based on milepost numbers. For Example, 5560 U.S. Highway 93 is 6/10 of a mile from MP55 towards MP 56. See **Figure No. 5**

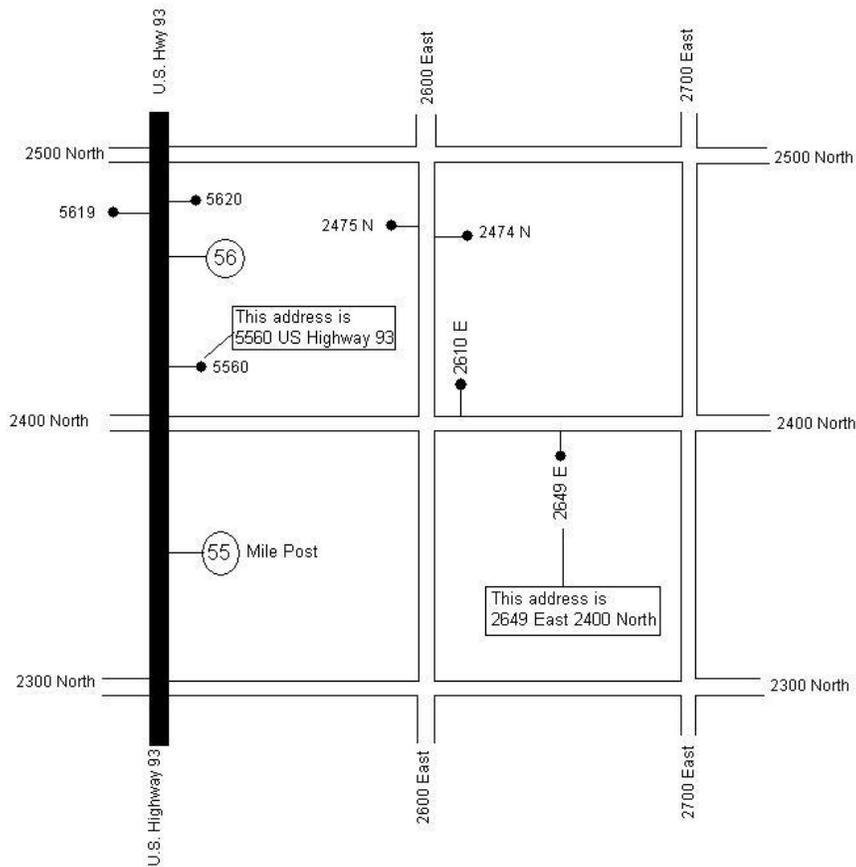

Structures

When assigning numbers, the middle of the structure should determine the number. Structures should always be numbered according to the road they face not where the mailbox is. When the house cannot be

seen from the road, then the driveway should be numbered and addressed on the road from which it departs.

Preplanning Subdivisions

New subdivisions can be addressed on a scaled drawing using an engineering scale. Road names will be addressed according to the preceding rules and examples. Structure numbers will be assigned by scaling to the center of the lot, from a known base line, and rounding either odd or even depending on which side of the road they are on. Preplanning requires that corner lots be numbered in both directions, since you don't know which way the house will face. Corner lots address will be assigned when the direction of the house is determined. Larger lots in subdivisions or parcel surveys; should allow room between structure numbers for lot splits, etc.

Approval

All addresses assigned in a new subdivision and new parcel surveys will be approved by the Twin Falls County Planning and Zoning Administrator.

NEW STRUCTURES AND MOBILE HOMES

All persons, firms, corporations and legal entities constructing new structures or relocating mobile homes in Twin Falls County, Idaho shall obtain an address, issued by Twin Falls County Planning and Zoning Office.

No utility company operating in Twin Falls County, Idaho shall furnish its utility services to any new structure or mobile home that is moved from one location to another, until a valid address has been issued. A new structure is defined as commercial building, house, or apartment newly constructed, being occupied by the applicant for the first time. The subscriber will be required to provide proof that an address notification form has been obtained. Proof shall consist of providing an assigned structure number and grid road name issued by the County.

Applicants shall apply for an address from the Twin Falls County Planning and Zoning Office in writing. Twin Falls County Planning and Zoning Office shall furnish the applicant with the address notification form necessary to present to the utility companies and US Postal Services. When a request is made the applicant will clearly mark the property in order to clearly locate the structure or property to be addressed.

After a request is made for an address it shall be issued within reasonable time. The Twin Falls County Planning and Zoning Office shall maintain a record of all addresses issued. A copy of all new addresses issued shall be sent to the following agencies: local post office, Qwest, other phone services providers, SIRCOMM, Assessors, Fire Department, and Highway District.

POSTING OF DESIGNATED ADDRESS NUMBER

The owner or occupant of person in charge of any house, building, mobile home or other structure to which a number has been assigned shall:

- Within 30 days after the receipt or notification of such number, affix the number in a visible place.
- Remove any different number which might be mistaken for or confused with the number assigned by the issuing authority.
- Each principal building or structure shall display the number assigned to the frontage on which the front entrance is located. In case the principal building or structure is occupied by more than one building or structure is occupied by more than one business or family dwelling unit, each separate front entrance shall display a separate number. Where suite or lot numbers are assigned, the suite or lot number shall also be displayed in the same manner as the house number.

- Numerals indicating the official numbers assigned to each principal building, or each front entrance to such building; shall be posted in a manner as to be legible and distinguishable from the street or road on which the property is located, with numbers painted or applied, of not less than two inches (2") in height.
- Mailboxes shall be marked with the house number.
- If the structure is not visible from the street or road on which it is located, and no mailbox is beside the driveway leading to the structure, a sign or number post shall be erected which will allow the numbers to be displayed either vertically from the top down or horizontally.
