ORDINANCE NO. 230

AN ORDINANCE OF THE BOARD OF COUNTY COMMISSIONERS OF TWIN FALLS COUNTY, IDAHO, READOPTING THE CITY OF BUHL'S BUILDING REGULATIONS AND ZONING AND SUBDIVISION REGULATIONS FOR APPLICATION IN THE BUHL CITY AREA OF IMPACT.

WHEREAS, in 2007 the City of Buhl and County of Twin Falls adopted, by ordinance, regulations for the area of impact for the City of Buhl; and,

WHEREAS, the County's ordinance has been codified in § 8-9-19(F) of the Twin Falls County Code; and,

WHEREAS, § 8-9-19(F)(3)(a) of the Twin Falls County Code adopts the Buhl City Comprehensive Plan and Map, the Buhl City zoning and subdivision regulations, zoning districts map, the area of impact maps and Buhl City Code Title IV for application in the Buhl area of impact; and,

WHEREAS, since 2007, Buhl City Code has been re-codified resulting in a renumbering and changing the Building Regulations to Title 8 and Zoning and Subdivision Regulations to Title 9; and,

WHEREAS, since 2007, the City of Buhl has adopted some changes to the zoning and subdivision regulations, which changes may be applicable to the Area of Impact; and,

WHEREAS, the Board of County Commissioners have examined the applicable ordinances enacted by the City, and finds that those changes should be incorporated for application within the City of Buhl Area of Impact.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF COUNTY COMMISSIONERS OF TWIN FALLS COUNTY, IDAHO:

The City of Buhl's building regulations and zoning and subdivision regulations contained in Buhl City Code title 8 and 9 are hereby adopted by reference by the County of Twin Falls to be in full force and effect in the area of city impact.

Ordinance No. 231

AN ORDINANCE REPEALING SECTIONS 8-3-1, 8-3-2, 8-15 AND ANY OTHER PROVISIONS THAT CONFLICT, AND ADOPTING SECTION 8-3-1 ADMINISTRATION AND OFFICERS, AND ADOPTING SECTION 8-3-2 COMPLIANCE, ADOPTING PROCEDURES AND AUTHORIZING PENALTIES FOR THE ENFORCEMENT OF THE PROVISIONS OF TWIN FALLS COUNTY CODES, PROVIDING FOR SEVERABILITY AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Board of County Commissioners of Twin Falls County, Idaho, deems it necessary to protect and promote the public health, safety and community welfare of Twin Falls County.

WHEREAS, the Twin Falls County Board of Commissioners anticipates the need to provide for the administration and enforcement of Twin Falls County Codes,

WHEREAS, a draft of this ordinance was considered by the Twin Falls County Planning and Zoning Commission at a duly noticed public hearing on the 7th & 9th day of February, 2012.

WHEREAS, a draft of this ordinance, and the recommendation of the Twin Falls County Planning and Zoning Commission was considered by the Twin Falls Board of County Commissioners at a duly noticed public hearing on the 20th day of April, 2012.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF COUNTY COMMISSIONERS OF TWIN FALLS COUNTY, IDAHO:

The Board of County Commissioners of Twin Falls County, Idaho hereby adopts the following as Twin Falls County Code Title 8 Chapter 3 Section 1 Administration and Officers, and Chapter 3 Section 2 Compliance:

8-3-1: Administration and Officers

A. Zoning Administrator

- a. **Appointment:** There is created the office of Zoning Administrator (Administrator), to be appointed by the Board of County Commissioners (Board).
- b. **Compensation:** The Administrator shall be paid a salary as may be determined by the Board. Such salary and other necessary expenses shall be paid from any appropriation made by the Board, together with any other funds which may become available by gift or by fees collected and placed to the account of the Planning and Zoning Commission (Commission).
- c. **Duties:** The Administrator shall be the administrative official of the Commission and shall administer the provisions of Twin Falls County Code (TFCC) as it relates to planning and zoning issues. In addition the Administrator shall:
 1. Receive and examine applications for, and issue, building permits, sign permits, zoning approval letters, and temporary use permits and maintain permanent records thereof.
 2. Conduct such investigations of buildings, structures, and use of land as are necessary to determine compliance with the terms of TFCC.
 3. Prepare application guidelines, forms, and administrative procedures.
 4. Receive, file and transmit to the Commission and/or the Board all applications, petitions and other communications on which it acts.
 5. Authorize such public hearings as are necessary to comply with the requirements and objectives of TFCC.
 6. Serve as an advisor to the Commission making recommendations on matters concerning rezoning, variances, special use permits, PUDs, subdivisions, zoning and comprehensive planning.
 7. Provide reports and discussions for use by the Commission on each item on the agenda.
 8. If an application for a permit does not qualify for the usage under the terms of TFCC, then the Administrator may deny the application, and/or may recommend other alternatives to the applicant.
 9. Maintain permanent records of all inspections and determinations made involving the inspection of buildings, structures and use of lands to ensure continuous compliance with the terms of TFCC.
 10. Order the abatement of violation of TFCC and order compliance with TFCC and, if necessary, aid in the prosecution of such violations.
 11. And any other such duties and responsibilities as may be assigned by the Board or as provided for in TFCC.
 12. Final determinations and actions of the Administrator may be appealed to the Board pursuant to the appeals procedure in TFCC.

- B. Planning and Zoning Director: It shall be the duty of the Director to assist the Administrator in the administration of the TFCC and in the absence of the Administrator to act in the Administrators stead.
- C. Building Inspector: It shall be the duty of the building inspector to assist the Administrator with the enforcement of the provisions of the building code.
- D. Code Enforcement Officer: It shall be the duty of the Code Enforcement Officer to enforce the provisions TFCC.
- E. Prosecuting Attorney: The Prosecuting Attorney of Twin Falls County may institute any necessary legal proceedings to enforce the provisions of TFCC.
- F. Sheriff: The Twin Falls County Sheriff and authorized representatives shall have the authority to enforce the provisions of TFCC.

8-3-2 Compliance

- A. General Provisions
 - a. No building permit may be lawfully issued, nor may an occupancy certificate be granted, until the Administrator has given authorization indicating all requirements of TFCC, all conditions of approval, and any other specific project related requirements have been met.
 - b. If any building or structure is erected, constructed, reconstructed, altered, repaired, converted or maintained, or any building, structure or land is occupied or used in violation of the provisions of TFCC or any amendment hereto, the County may pursue any one or more of the following actions:
 1. Seek voluntary compliance;
 2. Issue a civil citation (infraction);
 3. Pursue a civil action to enforce compliance with the terms of TFCC or to enjoin, restrain or abate any violation of the terms of TFCC; or
 4. Pursue criminal prosecution.
 - c. Violation of any conditions of approval, an administratively issued permit, a special use permit, or any other requirements of TFCC Title 8 is a violation of TFCC and may subject such permit to revocation. Revocation of any such permit may be made by the approving entity after notice and hearing as provided by TFCC.
 - d. Any violation of any conditions of approval, an administratively issued permit, a special use permit, variance, or any other requirements of any zoning ordinance is a public nuisance, and instead of, or in addition to, any other criminal or civil enforcement measure authorized by TFCC, may be enjoined or restrained by the County as other nuisances are abated under authority of applicable state law.
- B. General Penalties: Except as otherwise stated in TFCC, violations of any of the provisions of Title 8 shall be punishable as follows:
 - a. For a first violation the violator will be deemed guilty of an infraction and shall pay the fixed penalty of fifty dollars (\$50) per day that the violation continues.

- b. For a second violation within two years, the violator will be deemed guilty of a second offense infraction and shall pay the fixed penalty of one hundred dollars (\$100) per day that the violation continues.
- c. For a third violation within two years, the violator will be deemed guilty of a misdemeanor and may be fined up to one thousand dollars (\$1,000) and may be jailed for up to six (6) months.
- d. A citation shall be issued in person by a uniformed officer of the County or authorized designee, or may be mailed by certified mail, return receipt requested, to the occupant and the owner of record if the occupant is not the owner of record. The citation shall include the date(s) of the violation, the location of the property, and reference to the section(s) of TFCC violated.
- e. Each day of continuing violation may be assessed as a separate violation.

C. Whenever the Administrator shall determine that a violation has occurred, he shall notify the Prosecuting Attorney of such violation and recommend action that should be taken. Upon knowledge of violation, whether or not recommendation has been received from the Administrator, the Board may request the Prosecuting Attorney to commence action, criminal or civil, to correct the violation and to punish the same.

D. In the event any action is taken or any construction commenced in violation of the provisions of TFCC, the proper authorities of the County, in addition to other remedies, may institute any appropriate action or proceeding to prevent such unlawful action or construction or to restrain, correct or abate such violation or to prevent any illegal act, conduct, business or use in or about such premises.

Repeal of Conflicting Provisions and Severability: This ordinance hereby repeals all provisions of TFCC which conflict with the provisions of this Chapter. Irrespective of the basis of the invalidity, if any term or condition of this ordinance is invalid the remaining terms and conditions of this ordinance are severable.

Effective Date:

This ordinance shall be effective upon passage and publication as provided by law.
