WHEREAS, Idaho Code §31-808(11) provides for the transfer of funds held by the county as tax deed proceeds for owners of record who cannot be located to the county indigent fund;

WHEREAS, the county has proceeds from the tax deed sale of parcel number RP09S14E043601A formerly owned by Paul H. & Georgia R. Eaton. The former owners, Paul H. & Georgia R. Eaton, could not be located, are deceased, and have no known estate representative;

WHEREAS, such proceeds have been held in trust by the Twin Falls County Treasurer and at First Federal Bank for the past three years.

NOW, THEREFORE, be it ordered by the Twin Falls County Board of Commissioners: That the excess proceeds of \$639.00 from the sale of the above mentioned tax deeded property, held in trust plus interest accrued in the amount of \$3.52 for a total amount of \$642.52, shall be transferred to the County indigent fund as required by Idaho Code.
