# ORDINANCE NO. 243

# A TWIN FALLS COUNTY ORDINANCE PROVIDING FOR THE ESTABLISHMENT OF WARRANT OF DISTRAINT FEES PURSUANT TO IDAHO CODE § 63-1013

**WHEREAS**, prior to July of 2010, Idaho Code § 63-1013 provided for a fee of ten dollars (\$10.00) for issuing each warrant of distraint; and

**WHEREAS**, effective July 1, 2010, the Idaho State legislature amended Idaho Code § 63-1013 by deleting the ten dollar (\$10.00) fee and further providing that the fee for issuing each warrant of distraint shall be set by the board of county commissioners; and

**WHEREAS**, the Board of County Commissioners has determined, upon advice of the County Treasurer and after its own review, that the ten dollar (\$10.00) fee remains a reasonable fee for issuing such warrants; and

**WHEREAS**, the fee set by this Ordinance is neither a new fee nor is it an increased fee, but is only memorialized in County Ordinance because of the amendment of state statute.

**NOW, THEREFORE BE IT ORDAINED** by Board of County Commissioners of Twin Falls County, Idaho:

Section 1: That the fee allowed for issuing warrants of distraint, collection, levy and return of the same shall be, and hereby is, ten dollars (\$10.00) for issuance of each warrant.

Section 2: That such fee shall apply to all warrants of distraint issued by the Twin Falls County Treasurer and are served and executed by the Sheriff in the manner provided by law for the services of executions by levy upon personal property.

Section 3: This Ordinance shall become effective immediately upon passage and publication as required by law.

Animal Units shall not increase above those permitted.
