Commissioner Urie opened the public hearing at 10:00 a.m.

Glenn Johns spoke regarding the effect the increased taxes have on citizens. Mr. Johns noted that 1/3 of the taxes are for schools but he wanted to know if anyone has considered the effect the bonds have on the senior citizens. Commissioner Urie noted the hearing was in regard to the levy correction. Comment would be restricted to the issue of the levy correction. Gerry Bowden, Assessor, provided a letter of explanation of the correction and read it for the public in attendance. Citizen Wadi Fedaie questioned how the error occurred. Gerry Bowden explained the change that was made in error. Mr. Fedaie expressed concern about the checks and balances and was concerned about errors not being caught. Brent Hyatt commented and expressed appreciation how the county addressed this situation professionally. Wadi Fedaie expressed concern about the increase in taxes but schools failing. Mr. Fedaie questioned the increase every year. Mr. Fedaie noted he did not feel the tax payer should bear the burden of the error. Gerry Bowden noted had the error not been made the tax payers would have paid more to begin with and actually were charged less so this was a correction of the shortage. Commissioner Kramer asked Alan Dornfest how often this issue happens. Alan Dornfest, State Tax Commission, noted that while regrettable and causing extra work for the County, it has happened 6-7 times in the last 10 years. Mr. Dornfest noted that the system could always use improvement. There are edits in the programs to try and catch the errors, but there are a lot of moving parts to the system and overall it works pretty well. This instance, the increment value declined in the Urban Renewal Area, in comparison to the total value the change was small enough that it did not trigger an error. They will be more mindful to catch it in the future. Jennifer Bergin asked if any taxpayer is worse off than they would have been prior to the error. Gerry Bowden noted no, the taxpayer would have been correctly billed had the error not occurred. Debbie Kauffman, Treasurer, suggested that the taxpayers that addressed concerns with the School bonds go to the schools when they have their budget hearings. Commissioner Mills noted that the Commissioners are very concerned with the taxes and how they affect the citizens and they try to be mindful of how that affects the public. Commissioner Mills thanked the public for coming and expressing their concerns. Alan Dornfest noted that the State also will be paying a portion of the correction through the Circuit Breaker program for those citizens that the increase affected. Mr. Fedaie asked if the person who made the error has been terminated. Gerry Bowden noted that person has been disciplined but is still employed.

Commissioner Urie closed the public hearing at 10:25 a.m.

It is unfortunate that this happened.

RESOLUTION NUMBER 2016-023

WHEREAS, the Twin Falls County Assessor's Office made an unintentional clerical error in allocating value to a urban renewal parcel in Twin Falls County thereby inflating the general Twin Falls County property roll which resulted in errors to some levy rates certified by the Board of County Commissioners for Twin Falls County for 2015; and

WHEREAS, Idaho Code § 63-810 permits the Board of County Commissioners on its own motion to order all necessary corrections made in all property tax records; and

WHEREAS, a properly noticed public hearing to consider the levy corrections was held on March 11, 2016 at 10:00 a.m. in the Commissioner meeting room where any taxpayer could appear and be heard upon the levy corrections; and

WHEREAS, the Board of County Commissioners considered the evidence at the hearing;

NOW, THEREFORE, BE IT RESOLVED and ORDERED by the Twin Falls County Board of Commissioners that the levies shall be corrected as outlined in Exhibit A, attached.

Further, that based on this decision the Twin Falls County tax collector shall, prior to April 20, 2016, mail to the last record owner of any property in Twin Falls County affected by such erroneous levy a notice of tax correction. The deadline for paying the first half of such tax shall be no later than May 20, 2016; the second half shall be due June 20, 2016. Late charges and interest will be added if the first half is not paid by May 20, 2016, and the second half is not paid by June 20. Interest will be calculated from January 1 as provided in § 63-1001, Idaho Code.

In the Matter of ZONING

Commissioners considered an appeal of the P&Z Administrator's decision from Roger Duffin.

Attorney Gary Slette appeared representing the Appellant Roger Duffin, Rick Dunn P&Z Administrator, Andrew Havens, Building Inspector and Jennifer Bergin, County Attorney.

Jennifer Bergin, County Attorney, questioned Rick Dunn as to his position with the County and asked him to explain his understanding of the occupancy permit issue. Mr. Dunn reviewed the process that was used. Mr. Dunn noted what was provided by Mr. Havens was a final inspection not the building permit. Mr. Dunn noted there was not occupancy permit issued to Mr. Duffin. Mr. Dunn reviewed the process used for building permits. Ms. Bergin reviewed the letter sent to Mr. Duffin and noted there was an error in the letter, however the code section was addressed in the letter which referred to the sleeping area. Ms. Bergin reviewed the pictures and floor plans that were submitted by the P&Z Department and Mr. Duffin, which showed the outside of the property as well as inside.

Commissioner Urie questioned what happened with the new plans that were submitted. Mr. Dunn reviewed the process that the new plans did not meet the building code so they were not accepted.

Mr. Slette clarified that Mr. Havens was not an employee of Mr. Dunn, but of the County Commissioners. Mr. Slette asked the Commissioners to apply the law as indicated by Mr. Dunn's letter and must contain the 5 conditions. Mr. Slette disputed the property met those 5 conditions. Mr. Slette addressed the occupancy permit and disputed that the final inspection is

the last act of the building inspector and is the final step in the process to issue a certificate of occupancy. Mr. Slette discussed the canning kitchen and the inclusion of two sinks in the property as pointed out by Ms. Bergin. Mr. Slette asked the board to consider the objective language of the code and apply it to this case and reverse the decision of the Administrator.

Commissioner Kramer questioned the initial set of plans and approvals that had been given for plumbing and electrical. Mr. Dunn reviewed the process. Commissioner Urie questioned the second set of plans if the building would be approved as a dwelling if it was in a different location. Commissioner Mills questioned the change of building code referenced on the permit provided that said 2009. Mr. Dunn noted there is no change; the permit was just an example. Commissioner Kramer questioned the style of the garage, if it matched the motif of the home. Mr. Dunn noted the house is a craftsman style and the garage is the same style.
