Randy McGraw Southworth Associates, a recovering addict and counselor for addiction, spoke with the Commissioners and talked about his experience with addiction centers and gave statistics for department of corrections treatment costs and rates of recidivism. The recovery centers monitor pre-sentence and post-sentence offenders and are worth the cost and energy. He suggested state funds, federal funds and high quality bare bones treatment offset costs with treating offenders. Treatment is essential for complete recovery to include outpatient treatment. Mr. Southworth proposed several options for funding to include Dept. of Corrections, Veterans as well as self pay. Bill Brockman suggested some of the money from the state alcohol sales, a 5% fee could help fund this type of program, dedicated to drug and alcohol treatment centers. Commissioner Urie asked if any funding for the state treatment facility in Boise was coming from state money. Would this be competing with that facility? Rep. Leon Smith noted this facility was strictly for prison offenders. Commissioner Urie the issue is funding for this type of facility. I think we could be in favor of this type of usage for this facility, but it comes down to funding. The group discussed options for funding, as well as different types of management options. Dr. McClusky spoke on the need in the community for a long term treatment facility and expressed that this service is paid for one way or another by the communities. Commissioner Urie asked Dr. McClusky what options were available for people. Dr. McClusky stated there are minimal services and there was a large need in the professional community as for treatment as well as street addicts. Commissioner Mikesell we all recognize the issues and need to see some type of a business plan that would enable us to make a qualified decision. Bob Jackson with the VFW and DAV expressed interest in the facility to become an assisted living facility for veterans. John Hathaway advised the Commissioners not to let the hospital license expire if there was interest in the building as an assisted living facility

WHEREAS, a disaster emergency as defined in Idaho Code §46-1002 is in existence in Twin Falls County due to the imminent threat to life, livestock, and property created by the Long Butte Fire and Big Draw Fire; and

WHEREAS, Idaho Code §46-1011 authorizes the Commissioners of Twin Falls County, Idaho, to declare a disaster emergency to authorize the furnishing of aid and assistance, thereunder;

NOW, THEREFORE BE IT RESOLVED AND DECLARED by the Twin Falls County, Idaho, Board of Commissioners, as follows:

1. A disaster emergency is hereby declared to existing within Twin Falls County created by the Long Butte Fire and Big Draw Fire creating an imminent threat to life and property; and

2. These conditions require the activation of the response and recovery aspects of all applicable local disaster emergency plans; and

3. Such disaster may require Federal and State emergency assistance to supplement local efforts to protect, rehabilitate, and replace public property and to provide a coordinated multi-agency effort to mitigate, avert and lessen the threat and impact of the disaster.
