TWIN FALLS COUNTY RESOLUTION NO. 2012-019

WHEREAS, Congress enacted in 1908 and subsequently amended a law that requires that 25 percent of the revenues derived from National Forest lands be paid to states for use by the counties in which the lands are situated for the benefit of public schools and roads; and

WHEREAS, the principal source of revenues from National Forest lands is from the sale and removal of timber, which has been curtailed in recent years with a corresponding decline in revenues shared with counties; and

WHEREAS, the United States Congress recognized a need to stabilize education and road maintenance funding through predictable payments to the affected counties, and to achieve that goal enacted the Secure Rural Schools and Community Self-Determination Act of 2000, which was amended and re-authorized for FFY 2008 - 2011; and

WHEREAS, the United States Congress has re-authorized the Secure Rural Schools and Community Self-Determination Act for FFY2012 ("SRS2012"); and

WHEREAS, Title I of SRS2012 gives each eligible county the right to elect to receive either its traditional share of revenues from the National Forest lands pursuant to the Act of May 23, 1908 and Section 13 of the Act of March 1, 1911 (the "25-percent payments"), or instead to receive a guaranteed minimum share of the State payment pursuant to Sections 102(a)(1)(B) and 103 (the "full county payment amount"); and

WHEREAS, Twin Falls County elected in FFY 2012 to receive the guaranteed minimum full county payment amount pursuant to SRS2012 Sections 102(a)(1)(B) and 103; and

WHEREAS, an election to receive the full county payment amount is effective for all Federal Fiscal Year 2012; and

WHEREAS, any county electing to receive a full county payment amount that is \$100,000.00 or more must further elect to expend an amount not less than 15 percent nor more than 20 percent of its full county payment amount as project funds; and

WHEREAS, Title I, Section 102(d) of SRS2012 requires that counties electing to receive a full county payment amount of \$100,000 or more must allocate its project funds for between projects in accordance with Title II and Title III, and return the balance of project funds unspent under Titles II and III to the Treasury of the United States, and communicate such allocation to the Secretary of the United States Department of Agriculture; and

WHEREAS, Title II provides for special projects on federal lands or that benefit resources on federal lands, which projects are recommended by local resource advisory committees ("RACs"); and

WHEREAS, RACs recommend projects for consideration by the Secretary of Agriculture, with project funding supplied in whole or in part out of monies allocated for such purposes by participating counties; and

WHEREAS, counties that allocate funding to projects under Title II, and are participants in more than one RAC, may further direct that their Title II project funds be divided between different RACs according to an allocation decided by each participating county, with such funds held in the Treasury of the United States under the name of the county with a designation of the amount allocated to each RAC; and

WHEREAS, Title III provides for county projects, some of which are associated with federal lands, with Title III authorizing expenditures for search, rescue and emergency services, fire prevention and planning under the Firewise Communities program, and development of community wildfire protection plans; and

WHEREAS, a county with a full county payment amount of \$350,000 or more may not allocate more than 7 percent of its full county payment amount for Title III projects.

NOW, THEREFORE, be it resolved as follows:

1. Twin Falls County has elected to receive a full county payment amount that is less than \$100,000, and is not required to allocate any amount for projects under Titles II or III, but

may choose to do so. Twin Falls County elects to allocate 0 percent of its full county payment amount for projects under Titles II and III.

TWIN FALLS COUNTY ORDINANCE #232

AN ORDINANCE OF THE COUNTY OF TWIN FALLS, STATE OF IDAHO, EXEMPTING ALL OR A PORTION OF THE TAXABLE PROPERTY WITHIN FIRE AND AMBULANCE DISTRICTS.

WHEREAS, the Board Twin Falls County Commissioners have received applications and recommendations from Boards of the Salmon Tract Fire District, Twin Falls Fire District, Rock Creek Rural Fire Protection District, Buhl Rural Fire Protection District, Bliss Fire District, Filer Rural Fire District, and the Castleford Rural Fire District regarding property tax exemptions;

WHEREAS, Idaho Code § 31-1425 permits the Board of County Commissioners to exempt all or a portion of the taxable unimproved real property within a fire district from taxation and may exempt all or a portion of the taxable personal property within a fire district from taxation;

WHEREAS, the Twin Falls County Commissioners have previously adopted the recommendations of the Twin Falls County Ambulance District regarding tax exemptions by resolution number 2004-40;

WHEREAS, Idaho Code § 31-3908 permits the Board of County Commissioners to exempt all or a portion of the taxable unimproved real property within an ambulance district from taxation and may exempt all or a portion of the taxable personal property within an ambulance district from taxation;

NOW THEREFORE, BE IT ORDAINED BY THE BOARD OF COMMISSIONERS, OF TWIN FALLS COUNTY, IDAHO that the following tax exemptions for the following fire and ambulance districts shall be adopted and each category of property shall be treated uniformly:

- 1. Salmon Tract Fire District exempts the following categories of property from taxation: 55, 56, 59, 67, 68, 71, and 72.
- 2. Twin Falls Fire District elects to tax the following categories of property: 12, 15, 25, 26, 27, and 30 through 51, 57, 59, 65, and 68. Exempting all other categories from taxation.
- 3. Rock Creek Rural Fire Protection District exempts category 67 property from taxation.
- 4. Buhl Rural Fire Protection District exempts category 67 property and all LAND categories from taxation.
- 5. Bliss Fire District exempts category 67 property from taxation.
- 6. Filer Rural Fire District exempts category 67 property from taxation.

- 7. Castleford Rural Fire District elects to tax LAND categories 1 through 25 at 40% of the valuation, all IMPROVEMENT categories at 100% of their value, and PERSONAL PROPERTY category 65 at 100% of its value. Exempting all other categories from taxation.
- 8. Hagerman Fire district elects to tax all taxable property located in its district.
- 9. The Twin Falls County Ambulance District exempts categories 1 through 5 and personal property categories 55, 56, 57, 58, 59, 63, 64, 68, 70, 71, and 72 from taxation.

Effective Date: This ordinance shall take effect and be in force from and after passage, approval and publication required by law.
