There are pictures of the property that are current and show it was in productive Ag in the spring of 2009; show the irrigation system and the equipment that is used on that property. You can see that a very elaborate irrigation system was put in. The pictures show the irrigation system. The portion that looks not like the rest of the farm ground is cut for grass alphalfa every year. It is not plowed every year. We feel an honest mistake was made by the Assessor and we will do everything necessary to clear the question that we are not being truthful. The water is in the process of being split. The farm exemption was removed from only one parcel in the split. I am not arguing value; I am disputing the removal of the Ag exemption. I did not realize it had been removed because there is nothing to tell me on the assessment notice. Commissioner Urie we understand your concerns and will let the Assessor explain his position. Gerald Bowen, Idaho Code dictates what we do. Because the property was split that is why we went out to reassess the property. The taxes are set on the value of the property. The Ag exemption is not listed separately; it is included in the total value. There is a time set to appeal the value, once those values have been set, they are set and we can not go in and change the value. If there is a change to be made, it would be a cancellation by the Commissioners. John Knapple, when our appraisor was out there in September 2009, what he saw was weeds. It is all brown as you can see in the picture. He also took a picture of the entrance and it says no trespassing so he could not proceed further to see the irrigation equipment. So based upon what he was able to view, that explains why the value would have been changed. It did not appear to be farmed. Commissioner Urie I have property that is Ag exempt, if I choose not to farm it, when does the exemption change? John Knapple, on less than 5 acres, it is 3 years, but code does not specify on more than 5 acres and there are some other requirements but that is the general idea. We do not have enough people to appraise every year, so we just go on what we see on the day we are there. Commissioner Urie we can not change the value, except during the BOE appeal process the other option is a tax cancellation. Commissioner Kramer we will have to decide between the Commissioners and the Assessor if an error was made. John Knapple, I drove out and looked at it today and all of the irrigation system is in, the grass is seeded down and has been there for years. It is just an unfortunate thing that our person was there at a bad time. It is being farmed. ORDINANCE NO. 217

AN ORDINANCE ESTABLISHING A BUILDING CODE WITHIN TWIN FALLS COUNTY, IDAHO, ADOPTING THE 2009 VERSION OF THE INTERNATIONAL BUILDING CODE, <u>INCLUDING</u> <u>APPENDICES G AND I;</u> THE INTERNATIONAL RESIDENTIAL CODE PARTS I-IV AND IX, <u>INCLUDING APPENDICES G, H, AND J;</u> THE INTERNATIONAL ENERGY CONSERVATION CODE AND THE INTERNATIONAL FIRE CODE; PROVIDING THAT A PERMIT IS REQUIRED FOR INSTALLATION OF A MOBILE/MANUFACTURED HOME; PROVIDING EXCEPTIONS AND AMENDMENTS THERETO; ESTABLISHING PENALTIES FOR VIOLATION, PROVIDING FOR EXEMPTIONS; PROVIDING FOR SEVERABILITY AND REPEALING ORDINANCE 162 AND ANY OTHER

PROVISIONS THAT CONFLICT WITH THIS ORDINANCE, AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Board of County Commissioners of Twin Falls County, Idaho, deems it necessary to protect and promote the public health, property, safety and community welfare of Twin Falls County.

WHEREAS, the ordinance was considered by the Twin Falls County Board of Commissioners at a duly noticed public hearing on December 16, 2010.

NOW, THEREFORE, BE IT ORDAINED BY the Board of County Commissioners of Twin Falls County, Idaho, the Board of County Commissioners of Twin Falls County, Idaho hereby adopts the following:

Section 1: Purpose: The purpose of this ordinance is to provide minimum standards and requirements for regulating and controlling, grading, quality and installation of materials, use, occupancy, maintenance of all buildings, mobile homes, manufactu^red homes and structures in Twin Falls County.

Section 2: Code Adoption: The approved editions of the following 2009 nationally recognized codes as adopted by the state of Idaho and the Idaho Building Code Board, are adopted as the official building codes of the County of Twin Falls, except as provided in Section 3.

- The 2009 International Building Code, including <u>appendices G and I and all rules promulgated by</u> the Board to provide equivalency with the provisions of the Americans with Disabilities Act accessibility guidelines and the federal Fair Housing Act accessibility guidelines
- International Residential Code Parts I-IV and IX, <u>including appendices G, H, and J.</u>
- International Energy Conservation Code.
- International Fire Code.

The adopted versions of the foregoing codes shall be effective January 1, 2011. The foregoing codes shall be deemed superseded by successive versions of such codes as they are adopted or approved by the state of Idaho effective on the 1st day of January the year following the date any such codes are made effective for the state, unless a different date is required by state statute.

Section 3: Amendments to the adopted codes: That the following amendments shall be applicable to the adopted building codes:

A. To the International Building Code:

1. Definition: Agricultural buildings: A structure designed and constructed to house farm implements, hay, grain, poultry, livestock or other horticultural products. This place shall not be a place of human habitation or a place of employment, nor shall it be used by the public.

- B. To the International Residential Code:
 - I. The most current version of the Idaho Manufactured Home Installation Code.

Section 4: Exemptions: Agricultural buildings are exempt from the building codes adopted herein but shall remain subject to placement requirements and permits established by zoning regulations.

Section 5: Administration: The following requirements must be met, if applicable, prior to the issuance of a building permit.

- A. Applicants shall provide plans and specifications of sufficient detail to reflect compliance with code requirements.
- B. Submit a completed building permit application with the required supporting documentation.
- C. Whenever any work for which a permit is required by this ordinance or the building code has been commenced without first obtaining said permit, a special investigation shall be made before a permit may be issued for such work. An investigation fee, in addition to the permit fee shall be collected whether or not a permit is then or subsequently issued. The investigation fee shall be equal to the amount of the permit fee established by the Board of Twin Falls County Commissioners.
- D. The design criteria for Twin Falls County shall be:

Ground snow load 30# Wind speed 90mph with 3sec. gust Seismic design C Weathering Severe Soil bearing Pressure 1500# Frost depth 24"min. Flood zone Site specific Termite Slight Elevation 2900 to 4900

Unless determined differently based on the site evaluation by a qualified design professional.

Section 6: Fees: The Board of Twin Falls County Commissioners may establish fees for the issuance of building permits, plan reviews, re-inspection and other such fees as may be necessary to accomplish the purpose of this ordinance. Applicants shall pay permit and plan review fees in amounts to be determined by Resolution of the County Commissioners. All permits required under this Ordinance require fees to be paid prior to a permit being issued, unless specified otherwise herein.

Section 7: Manufactured Homes Installation Permits: Placement of mobile/manufactured homes shall require an installation permit. The permit applicant shall supply to the Building Official the same site information required from an applicant seeking a building permit for a single family dwelling and shall pay a permit fee as set by resolution of the County Commissioners.

Section 8: Violations: Violations of any of the provisions of this chapter or failure to comply with any of its

requirements may be dealt with in the following manner: each day such violation continues shall be considered a separate offense, and shall constitute a misdemeanor as defined by Idaho Code and is punishable by up to six months in jail and up to three hundred dollars (\$300.00) fine, or both; the county may seek civil penalties and forfeitures to the maximum extent allowed by law. In the event that a violation threatens the public health, safety and/or general welfare, the Board of County Commissioners may take any lawful action it deems necessary to abate such violation.

Section 9: Severability: The ordinance is hereby declared to be severable. Should a court of competent jurisdiction declare any portion of this ordinance invalid, the remaining provisions shall continue in full force and effect and shall be read to carry out the purpose(s) of the ordinance before the declaration of partial invalidity.

Section 10: Repeal of Conflicting Provisions: All provisions of the Current Ordinance 162 of the Twin Falls County Code is repealed. All provisions of the Twin Falls County Code which conflict with the provisions of this ordinance are hereby repealed to the extent of such conflict.

Section 11: Effective Date: This ordinance shall be effective upon passage and publication as provided by law.

Brenda Hughes, in the current market, there is no data that supports the value that the Assessor came up with. I do have sales data from MLS from November 2009 to date, and the value is not warranted. We propose a value of \$500,000.00 which is more in line. Idaho is highest in property decline in the nation.

Gerald Bowdin Assessor, by Idaho Code we can only look at sales between October 2009 through September 2009. It is a requirement. We compare sales with the assessed values and we must be within 90-110% of those ratios. If we are not, the State Tax Commission will adjust those for us.

Brian Thompson, I went out to the property and spoke with Mr. Hughes and he gave me permission to measure the outside of the home. I later spoke with Mrs. Hughes and told her I had to estimate the interior and suggested I reappraise the interior and she was not interested in that at that time. John Knapple, the packet you have shows the data we use and pictures of the home and notes from the appraisal. John Knapple explained the procedure used to reach the assessed value. Commissioner Urie so are there any comparable properties on the map you provided? John Knapple, none of these are in that subdivision, but there are 3 in outside Kimberly, two of them are single floors. It is difficult to find comps as large as this one that are all on one floor. Gerald Bowdin the homes in that subdivision are all appraised on the same basis.

Brenda Hughes, on the comp data that is provided, the majority of them are not in the Kimberly area so I don't see that they are valid comps. On the square footage, the garage is 100 ft less. Most appraisers will agree that cost approach does not match with current sales data. Brenda also noted the house across the street sold in December 09, for just under \$400,000.00 but that was outside the timeframe allowed.

Commissioner Kramer asked the Assessor questions on the grades of homes. John Knapple clarified the codes listed on the report categorizing the homes. Gerald Bowdin, the cost approach is not just a pure cost approach, but it also has market elements and depreciation included. Commissioner Kramer noted they have not had an appeal of this type, what does the Tax Commission generally do? Gerald Bowdin, An occupancy value has to be related to the time frames, but the taxes are pro-rated. The value put on is based on the timeframe we have to look at.

Brenda Hughes, I would appreciate it if it could be reviewed again. I know we could not sell this home for \$500,000.00 but we are willing to accept that value. Gerald Bowdin,

we were not able to enter the home to do the appraisal and we did measure the outside and we used the plans. This property was appraised using the same data as all the other properties for 2010 taxes. Next year we will have new data. We feel we are within the guidelines and the value is reasonable for the property. Brenda Hughes, I did try to make appointments with the appraiser, but no one would ever call us back so it got to the point where we did not feel it would help us and what is inside the home is not relevant to the value. The plans you have are identical to the home.
