The undersigned Members of the Board of County Commissioners for Twin Falls County ("County") hereby certify that the following resolution was duly moved, seconded, and unanimously adopted by the County at a duly called regular business meeting held on December  $22^{nd}$  2011.

# RECITALS:

- A. Section 1.2 of the Sale and Lease Agreement between St. Luke's Health System, Ltd. ("St. Luke's") et. al. and Twin Falls County requires St. Luke's to obtain the approval of Twin Falls County prior to amending certain sections of St. Luke's Bylaws; and
- B. Twin Falls County and St. Luke's desire to amend St. Luke's Bylaws in accordance with the resolution set forth below.

# **RESOLUTIONS**

RESOLVED, that Twin Falls County approves amending Sections 2.2 and 3.4 of the Bylaws for St. Luke's Health System, Ltd., effective January 1, 2012, as follows:

#### 2.2 COMPOSITION OF THE BOARD

- **B.** After the initial six (6) year period of the Corporation, the Board of Directors shall revert to a self-perpetuating body consisting of at least eleven (11) and not more than fifteen (15) Directors. The Board shall be comprised of at least two (2) Directors who reside in Twin Falls County and three (3) Directors who reside in the Treasure Valley.
- **3.4 NOMINATING COMMITTEE.** At the discretion of the Board, the Board may choose to carry out the Nominating Committee functions as a committee of the whole. If the Board does not elect to serve as a committee of the whole, then the Nominating Committee shall be composed of at least five (5) members, including the Chair and Chair Elect of the Board, the President/Chief Executive Officer and two (2) other Directors appointed by the Chair of the Board. In the event that the Nominating Committee is formed during a time when the position of Chair-Elect is vacant, the Chair of the Board will appoint an at-large Board member in order to meet the required number of Nominating Committee members. In the event the Board does not serve as the committee of the whole, the appointed members shall serve at the pleasure of the Chair of the Board.

The Nominating Committee shall identify Director candidates for appointment by the Board. Prior to the expiration of a Director's term, there will be a general solicitation of nominees from the Affiliates. The slate of nominees shall be prepared at least thirty (30) days prior to the Corporation's annual meeting and shared with the Affiliates. At the Board's direction, a subset of the Nominating Committee may be created to review all recommendations for appointment to Affiliate Boards.

The Nominating Committee shall also identify Director candidates to stand for election as Chair-Elect of the Board at least thirty (30) days prior to those annual meetings of the Corporation occurring at least one (1) year prior to the expiration of the current Chair's term. The Nominating Committee shall also identify separate candidates to stand for election in the offices Secretary and Treasurer of the Corporation when requested by the Board.

When the Director seat in question is required to be filled by a person from a certain geographic location, in order to maintain the minimum number of seats required pursuant to Section 2.2 above, the Affiliate represented by the seat in question will identify candidate(s) for election to the Board of Directors. If the Corporation's Board of Directors does not agree with the person(s) identified by the Affiliate's Board of Directors, the Affiliate may submit alternate nominations until a new Director is agreed upon by Corporation's Board of Directors.
