In the Matter of ZONING

Commissioners considered Shoshone Heights PUD Subdivision 1 & 2 final plats.

Renee Carraway from Twin Falls City P&Z department presented the final plats and advised the Commissioners that the City Council had approved the plats and the extension request.

Commissioner Kramer made a MOTION to extend the final plats as recommended by Twin Falls City. Commissioner Mills SECONDED. Discussion Commissioner Kramer the economy is such that several of these are requesting extensions and there have been no changes so we will go with the city's recommendations. Motion Passed Unanimously. (Urie absent)

In the Matter of PUBLIC HEARING

Commissioners conducted public hearing for Re-zone request for Triple C from R-4 to M-2.

Commissioner Kramer opened the public hearing for public comment.

Michelle Hall, property manager for Rock Creek Mobile Manor representing the residents of the trailer park to the south of the property, expressed concerns about the change and issue's they have observed with dust, noise and traffic issue's. Michelle presented a request signed by approximately 50 residents requesting several adjustments be made to the property, specifically a sound retention wall on the south side of the property toward resident's homes, and they requested a time restriction for operations due to the noise. She also expressed concern that the property being industrial would lower property values, and the residents want to preserve the value of the property. Commissioner Kramer asked Renee Carraway if M2 was a heavy industrial zone and she confirmed it was.

Ray Reynolds, property borders the triple C property on the south side. He expressed concerns that the fence needs to be a sound barrier and a dust barrier that conceals the property.

Lee Harman lives directly East of the Triple C property and borders the property. He noted that the wall that previously was there was 10 ft high but has been removed. His property is exposed to the dust and cement and it sticks to his personal property. He requested a retaining wall to protect his property. He noted that when it was dry, Triple C has been very diligent about watering to keep the dust down during the day, but it is a problem at night.

Jeff Coats, Triple C Concrete field operations manager, advised that they have given a letter of commitment to the city to put in a fence and dust control issues are regulated by DEQ and are addressed daily on their other properties. They need room to organize their property. There is no access to Grandview Lane from that property so there will be no extra traffic on Grandview. Jeff expressed that he lives by the property and his property will stay residential and he will not be allowing access to Triple C through his property. Commissioner Mills questioned if the property was already being used as M2. Jeff replied they have put equipment in there and they want to be compliant with the M2. There was discussion of the use of the property and the type and size of wall that is proposed.

Ernie Hall expressed concern about the noise early in the morning is very disturbing to the neighbors. He asked that the wall be a minimum of 8 feet to help with the noise. Mr. Hall noted that the neighbors are concerned that the residents would be pushed out of the neighborhood by the industrial use.

Lee Harman expressed concern that a fence 6-8 ft high would not help as the piles of debris are much higher than that. He asked that the fence be a minimum of 10 feet high.

Commissioner Kramer asked Mr. Harman to point on a map where his property is located in conjunction with the existing Triple C property. Mr. Harman designated the area on the map where his property is, directly to the east of the existing Triple C facility and is not part of the rezone area. Mr. Harman and Commissioner Kramer discussed the area that would be rezoned and the current use of those properties.

Ray Reynolds lives directly south east and his property runs the full length of the property in question. He has 7 acres and lives right next to Jeff Coats. Mr. Coats has a 10 ft fence barricading his property and requested that the 10 ft fence extend the full length.

Todd Coats, manager of Triple C., noted that the wall referred to is a temporary block wall that has been there for years. A 10 foot wall is not feasible due to the cost. The proposed wall is precast panels that are 8 ft high and will look nice. A 10 ft fence is not feasible due to the cost. Mr. Coats described the proposed wall. Commissioner Mills asked if a berm could be used to help raise the size of the fence. Todd Coats said they are looking at all options. Commissioner Kramer asked what the current use is. Todd Coats said they currently have equipment stored on it and admitted it has looked junky but is in the process of being cleaned up. He also noted that occasionally there will be equipment that could be higher than the fence.

Ernie Hall noted that Triple C has done a great job of trying to clean things up. He expressed confidence that Triple C would work with the residents to make things work.

Commissioner Kramer closed the public hearing.

Commissioner Kramer asked if the city has placed any conditions on the approval of the re-zone. Renee Carraway advised there were no conditions placed on a rezone, but the applicant did commit to put up a fence.

Commissioner Mills questioned who was responsible for the road debris. Commissioner Kramer noted that the highway district was responsible for maintaining the road and noted that there is a code enforcement officer that can be called if there is a hazard.

Commissioners conducted a public hearing to consider a vacation request.

Renee Carraway gave the Commissioners background on the property requested to be vacated. Ms. Carraway noted that there is a dedicated undeveloped right away and the city does not have issue with vacating the right of way and splitting the property between the 3 adjacent land owners. Idaho power has requested to retain a certain amount of the easement. The city council has recommended the vacation.

Commissioner Kramer noted that the vacation of the property would eliminate the potential for access into the Triple C property from the previous re-zone request.

Commissioner Kramer opened the public hearing.

Lee Harman spoke representing all parties on the vacation request. Mr. Harman expressed the need for Triple C to have this completed and the property to be vacated for their use.

Jeff Coats explained there is a small amount of the property that borders his ground so there are 4 property owners requesting the vacation request.

Commissioner Kramer closed the public hearing.

Commissioner Kramer made a MOTION to take the re-zone from R-4 to M-2 under consideration and issue a written decision in 10 days. Commissioner Mills SECONDED. Discussion Commissioner Kramer because there were so many people who spoke in regard to this request, I would like to take a little more time to consider my decision. Motion Passed Unanimously. (Urie absent)

Commissioner Kramer made a MOTION to allow the vacation of the right of way closing Willow Street. Commissioner Mills SECONDED. Discussion Commissioner Kramer the neighbors are all in agreement with closing this street. Motion Passed Unanimously. (Urie absent)
