There are requirements that I have to meet to have gravel quarry that they have not had to meet. They are getting paid to have a gravel quarry and we are trying to survive and the competition is too much. Commissioner Mikesell I did abstain from the original decision on that. It was intended to be a clean up and the attorneys put in the agreement to change it from the clean up. Gordon Paving, we did not see the need to bid on the clean up, but had we known what it was going to develop into, we would have bid. They are bringing in blasting and it is clearly a quarry, not just a clean up. I don't think there are any government agencies that would not consider it a rock quarry and they have not gone through the proper procedures. The bottom line is if they can do it, we would like the opportunity to as well. You could call BLM to determine what they call a rock quarry. We can not compete with that and it is not fair competition. No one can compete with that and with the economy, it is really hurting us. We wanted to open that dialog. Commissioner Urie we will have to review it. We kind of inherited it, I understand what you are saying and we are getting different stories than what you are saying. I can't answer the quarry questions or location, but we need to look into that. Commissioner Mikesell it was always the intent to put the 4% grade on this, and the blasting was part of the intention. Also he does have the right to move material in and out as he sees necessary. He can bring rock in and crush it for 7 years. We were hearing the exact opposite story from him not long ago. So it is obvious the market is having difficulty at this time. Gordon Paving, he has 7 years to clean it up, not produce. That is the problem right He is mining the property. And the bidding process was questionable. Commissioner Mikesell the bidding process was done correctly and we did have inquires. Gordon Paving, we saw it and it was listed as a clean up. Commissioner Mikesell I was involved in the whole process and it was all done legally, and then when

McCoy was the only bidder I stepped out of the picture due to conflict. Commissioner Kramer we will find the documentation on this and look into it.

It appears there is a charitable division in the cemetery in Twin Falls and we pay them the same amount as we would for you. Commissioner Urie the only thing we need to do now is write up an official agreement so later when board members have changed, it is able to be budgeted for. We will have our attorney draw something up and then we can all agree on it before it is signed.

# A RESOLUTION TO ADOPT THE STATE PLAN FOR DEFERRED COMPENSATION

WHEREAS, the State of Idaho has enacted Idaho Code Section 59-513 which permits the State of Idaho and any County, City or political subdivision of the State, working through its governing body, to contract with an employee to defer income to a 457 Deferred Compensation Plan; and

WHEREAS, the State of Idaho, by the State Board of Examiners has established and maintains the Deferred Compensation Plan ("Plan") for participation by state employees and by local public employees; and

WHEREAS, Twin Falls County, Twin Falls, Idaho (hereinafter referred to as the "Participating Employer") desires to adopt the Plan for participation by its employees; and

WHEREAS, the Participating Employer has also determined that it wishes to encourage employees' saving for retirement by offering salary reduction contributions; and

WHEREAS, the Participating Employer has reviewed the Plan; and

WHEREAS, by adopting the Plan, the Participating Employer adopts the investments and services selected by the State of Idaho Board of Examiners;

NOW, THEREFORE BE IT RESOLVED by the Twin Falls County Board of Commissioners:

- Section 1. The Employer shall abide by the terms of the Plan, including amendments to the Plan made by the State of Idaho Board of Examiners, all investment, administrative, and other service agreements of the Plan, and all applicable provisions of the Internal Revenue Code and other applicable law.
- Section 2. The Employer may terminate its participation in the Plan, if it takes the following actions:
  - (a) A resolution must be adopted terminating its participation in the Plan.
  - (b) The resolution must be filed with the State of Idaho Board of Examiners within fifteen (15) working days of approval by the governing body of the local public body.
  - (c) The resolution must be filed not less than two years after the date of Employer's participation become effective.

The Twin Falls Board of County Commissioners has authority to execute, on behalf of Twin Falls County, documents to implement the Plan for Twin Falls County and to take action to correctly maintain the Plan under this Resolution.

APPROVED by the Governing Body of the Twin Falls County Commissioners this  $26^{\text{th}}$  day of March, 2010.
