McClure Engineering, your systems are generally appropriate for what you are using them for and are generally in good shape. You are not looking at a complete replacement but you could make some improvements that would save you a substantial amount of money. The refrigerant that is in the cooling system is being discontinued. Over an extended period of time it will become more expensive to operate. You will need to replace it at some point to take advantage of less expensive refrigerants. But I would not say that is immediately necessary. The cooling tower is corroded and you are running water through it year round. The fans limit the amount of

air flow and it is not an ideal situation because you are losing heat in the winter. You can put dampers on it to eliminate or control the amount of outside air or put variable speed motors on your fans to lessen the electricity use. The boiler is oversized for what you need which means you are operating at a lower efficiency. There are different types of boilers that are more efficient. You would save on the gas energy, but the existing boiler is working and has been well maintained. Your pumps are in good shape. Your heat recovery system is only about 30% efficient compared to what is available now is about 70% efficient. The exhaust fans need replaced because of the age and the condition and the additional heat from there could be reused with an updated system. HVAC controls, you would substantially benefit from modifying or installing new controls in the building. The water heater needs to be replaced. You could also save on your water through the refrigeration system. Light replacement would save substantially as well. There are incentive programs for that through Idaho Power. The courthouse system, is working well for you, but could also have some updates that would give you some savings there as well.
