AN ORDINANCE OF THE COUNTY OF TWIN FALLS, IDAHO, ADOPTING BUHL CITY ORDINANCE NUMBER 970 AS APPLICABLE IN THE AREA OF CITY IMPACT.

WHEREAS, Idaho Code §67-6526 requires every county and city within each county to negotiate an area of city impact, and plans and ordinances regulating uses within the established area of city impact; and

WHEREAS, Twin Falls County Ordinance Title 8 Chapter 9 Section 19(F) governs the area of city impact for the City of Buhl, Idaho; and

WHEREAS, Twin Falls County Ordinance Title 8 Chapter 9 Section 19(F)(3) adopts Buhl City Code titles 8 and 9 as the governing plan and ordinance for the impact area for the City of Buhl;

WHEREAS, the City of Buhl, Idaho has by ordinance adopted an amendment to its Buhl City Code 2010, Title 9, amending section 9-2-3 to add the definition of "utility;" and amending section 9-8-1 schedule of land use controls to provide that public service facilities, public uses, public utility, and utility may be allowed in all zones as a conditional use upon the issuance of a conditional use permit. The issuance of a conditional use permit shall be subject to the requirements of Buhl City Code. Further, all ordinances, code sections, or parts thereof in conflict with this amendment are repealed and the ordinance shall be in full force and effect upon its passage, approval, and publication.

WHEREAS, it is recommended by the City of Buhl that such ordinance change be adopted by the Twin Falls Board of County Commissioners; and

WHEREAS, a draft of this ordinance, and the recommendation of the Twin Falls County Planning and Zoning Commission was considered by the Twin Falls Board of County Commissioners at a duly noticed public hearing on the 23rd day of May, 2013.

NOW, THEREFORE BE IT ORDAINED BY THE BOARD OF COUNTY COMMISSIONERS FOR TWIN FALLS COUNTY, IDAHO:

- 1. Buhl City Ordinance 970, amending Buhl City Code 9-2-3 and 9-8-1, is hereby adopted as applicable in the Buhl City area of Impact. (See, attached).
- 2. Twin Falls County affirms title 8 and 9 of the Buhl City Code as the governing ordinance for the impact area of the City of Buhl.
- 3. Severability: The ordinance is hereby declared to be severable. Should a court of competent jurisdiction declare any portion of this ordinance invalid, the remaining provisions shall continue in full force and effect and shall be read to carry out the purpose(s) of the ordinance before the declaration of partial invalidity.
- 4. Effective Date: This ordinance shall be effective upon passage and publication as provided by law.
