The exemption is for a five-year period beginning in Property Tax Year 2019. The exemption base value will be the 2018 Property Assessment Value including the commercial land, the commercial building and the personal property.

The amount of value exempted will be the value of the current year Property Assessment Value less the exemption base value multiplied by the percentages granted below. This is referred to as exempted value.

Property Tax Year 2019 - 100% of the exempted value.

Property Tax Year 2020 - 100% of the exempted value.

Property Tax Year 2021 - 90% of the exempted value.

Property Tax Year 2022 - 80% of the exempted value.

Property Tax Year 2023 - 70% of the exempted value.

The complete terms of this exemption will be finalized by an agreement between the County Commissioners and Jayco, Inc.
