AN ORDINANCE MODIFYING TWIN FALLS COUNTY CODE TITLE 5 CHAPTER 5: SUBPARTS 3 AND 4 REGARDING FIREWORK PERMITS.

WHEREAS permits for sale of fireworks and public display of fireworks are currently issued by Twin Falls County;

WHEREAS fire departments and fire protection districts are the authorities having jurisdiction to issue permits for sale and public display of fireworks in Twin Falls County under Idaho's Fireworks Act of 1997 (Idaho Code § 39-2601 *et seq.*);

WHEREAS, the Board of County Commissioners of Twin Falls County, Idaho, deems it necessary to protect and promote the public health, safety and community welfare of Twin Falls County for permits to be issued by the authorities having jurisdiction; and

WHEREAS, a draft of this ordinance was considered by the Twin Falls Board of County Commissioners at a duly noticed public hearing on the 14th day of November, 2017.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF COUNTY COMMISSIONERS OF TWIN FALLS COUNTY, IDAHO:

Twin Falls County Code 5-5-3 and 5-5-4 are hereby amended to read as follows:

5-5-3: SAFE AND SANE FIREWORKS; PERMIT:

- A. Permit Required: It shall be unlawful for any person to sell, store, or keep for sale any safe and sane fireworks anywhere within the County of Twin Falls unless such person be the holder of a valid permit for sale of safe and sane fireworks.
- B. Application process: Permits shall be obtained by applying to the city fire department or fire protection district that has jurisdiction for the area where the proposed sale of fireworks is to take place.
- C. Sale: No safe and sane fireworks shall be sold, or offered for sale except from twelve o'clock (12:00) noon June 15 to midnight on July 5 of each year.

5-5-4: PUBLIC DISPLAY OF FIREWORKS; PERMIT:

- A. Permit Required: It shall be unlawful for any person to conduct a public display of fireworks within the County of Twin Falls unless such person be the holder of a valid permit for the public display of fireworks.
- B. Application process: Permits shall be obtained by applying to the city fire department or fire protection district that has jurisdiction for the area where the proposed public display of fireworks is to take place.

Effective Date:

This ordinance shall be effective upon passage and publication as provided by law. Approved by the Board of County Commissioners of Twin Falls County, Idaho, on this 14th day of November, 2017.
