- Project specifics including a discussion on the District's Fire Master Plan, the proposed fire station, cost estimates, project budget, and the project schedule.

After Mr. McCurdy's remarks, the meeting was opened to the public for comment. During the public comment period, the County Commissioners asked some questions regarding the proposed project.

Commissioner Urie asked who conducted the Fire Master Plan. Mr. McCurdy responded stating that it was Citygate Associates, LLC, a Fire & Emergency Services, a consulting firm from Folsom (Sacramento), California.

Commissioner Urie asked who conducted the survey and if the City of Kimberly was included in the survey area? Jason Keller from the Rock Creek Rural Fire Department responded saying that he and his firefighters conduct the survey. Commissioner Urie questioned whether the survey was conducted properly because the City of Kimberly is not currently annexed into the Fire District. Mr. McCurdy responded saying that the survey area did include the City of Kimberly. Following the regulations of the ICDBG program, the City of Kimberly is within the benefit area of the project and had to be included in the survey. Regardless of how the fire services are paid, the Fire District responds to calls within the City of Kimberly. The District will continue to respond to calls within the City after the project is completed. As such, the residents of Kimberly needed to be included to determine the eligibility of the residents that would benefit from the project.

Commissioner Mikesell stated that he was advised that the Fire District may be organized in violation of Idaho Code. He provided Idaho Statue 31-1408 to the public which states that if the

Fire District is situated in two or more counties, not more than two of the fire protection district commissioners shall be from the same county. Where the Fire District covers eight (8) square miles of Cassia County, the Fire District needed to have representation from Cassia County as well as Twin Falls County. Mr. Mikesell stated he could not support the Block Grant Application unless this issue was resolved. There was a discussion among those in attendance regarding the organization of the Fire District. Fire District Commissioner Jack Clairborn reported that the District legally followed Idaho Code to form the District. Mr. Mikesell said the way he interprets the law, Cassia County is not represented. He stated that he could not support the Block Grant application unless this issue is resolved or a plan is in place to resolve the issue.

A **RESOLUTION** OF **THE** BOARD OF **COUNTY** COMMISSIONERS, TWIN FALLS **COUNTY**, **IDAHO**, **AUTHORIZING THE CHAIRMAN** TO SIGN AND **SUBMIT** AN APPLICATION FOR AN **IDAHO COMMUNITY DEVELOPMENT** BLOCK GRANT TO **PARTIALLY** FINANCE **THE CONSTRUCTION** OF A FIRE STATION TO **SERVE THE** AREA OF **THE** ROCK CREEK RURAL FIRE PROTECTION DISTRICT IN EASTERN TWIN FALLS **COUNTY**.

WHEREAS, Twin Falls County is committed to provide safe and accessible public facilities and quality programs for its citizens; and

WHEREAS, the Rock Creek Rural Fire Protection District provides an invaluable service to the residents that live in the County and to the motorists that travel through the area; and

WHEREAS, the Fire District has a Fire Master Plan that recommends the fire station located in Kimberly be improved or replaced; and

WHEREAS, the Fire District has determined that improving the existing station is not feasible and therefore has developed a plan to construct a new fire station and training facility that will address the needs of the Fire District for the next 20 years; and

WHEREAS, the residents of Twin Falls County and the Rock Creek Rural Fire Protection District are unable to financially bear the burden of constructing the new facility themselves and therefore need the assistance of the Idaho Community Development Block Grant to help construct the new station and training facility.

NOW **THEREFORE, BE** IT HEREBY **RESOLVED** BY **THE BOARD** OF COMMISSIONERS FOR TWIN FALLS **COUNTY, IDAHO,** that the Chairman is hereby authorized to sign and submit appropriate application materials to Idaho Department of Commerce for funds to assist the County and the Rock Creek Rural Fire Protection District with the construction of a new <u>fire</u> station in Twin Falls County.
