The waiting list for housing was to long and I was not able to get in. One company paid for the rent for 6 months only. So we were forced to return to the house that was burned and we were living there. So in July of 2006, we returned to the house and lived there. Assistance was no longer available. Every year when we came to pay the taxes, we did not know we did not qualify for the circuit breaker. In 2008 we received a letter saying we were responsible for the taxes. They said we no longer got assistance because the house was burned. I said I have proof I was living there. I was

waiting for 3 years and in October, I was able to get into the program and get an apartment where we are now living. I am asking you to waive the taxes for 2007 because we were living in the house. I am not asking for 2009 because I am not living in the house for 2009. In 2006, the tax was \$350.00. I received \$500.00 in government help so I was able to pay the taxes. I have no money left to pay the taxes for 2007. I have a family, the kids need clothes, school supplies and I do not have enough money to pay. It costs \$60.00 to pay school fee's and I have 5 kids in school. I am asking you to cancel the taxes for 2006. Commissioner Urie So he does not live in the house now? Vladimir Kryshtal through interpreter he does not live in the house now, the city will not allow him to live in what is left. The water and electric is shut off. They said it is a garage and he can't live there. Commissioner Urie why does he keep the property if he does not live there? Vladimir Kryshtal through an interpreter he is not keeping it, he does not know how to sell it. He wants to sell it. Commissioner Urie does he own the property outright? Vladimir Kryshtal through interpreter he does not owe anything on the property. In 1997, he was no longer able to work and he got disability. He believes in 2009, the taxes will be really small and will only be the property, not the home. Gerry Bowden, County Assessor we were allowed to assess the property on the 18th of September and the value adjusted to \$34,674.00, we will do a cancellation for 2009 for the difference in value. There was severe damage to the property from fire and there was some remodeling done. I have some photo's with the progress and there was some problems with the city and the building permits. The city asked them to move off the property because of this. I believe it was in 2008. Commissioner Kramer the fire was in 2005? So in essence this property is in the same condition it was in 2005? Gerry Bowden not really, we were not allowed to do an appraisal until recently. They had circuit breaker on the home and when they moved out, they lost that. Once we were able to get into the property, we were able to adjust that because it looks better from the outside than it is. Commissioner Urie has he tried to sell the property? Vladimir Kryshtal through interpreter he used to live there, how could he sell it? He disagree's with the appraisal, he was not able to make very good upgrades because he is disabled. The city told him everything that is on the property should be removed. They referred to a code. It would cost him \$10,000.00 to remove the remnants from the property. He believes if you take \$10,000.00 from the cost of the lot, which is \$20,000.00, that would be the value. He consulted with the city and they asked him to demolish all the construction. They came over and disconnected, they cut down all the lines and said only if they demolish, will they reconnect them. No one will buy the property because it is a violation of city code. He says it is only worth \$5000. Commissioner Urie does he understand what happens if he does not pay the taxes? Vladimir Kryshtal he used to live there and as a poor person that the government helps and he should get the help. He lived there. He has electrical bills and cable bills. He was only out of there in 2008 and he lived there without electricity for 6 months because he had no other place to go. Commissioner Urie the problem is he still has no place to live and waiving the taxes does not help him. Vladimir Kryshtal through interpreter he disagree's, he believes if you help him pay for 2007 and he will be able to pay the 2009 and then will sell the property. Commissioner Mikesell there is no help if he is not living there. So he will still owe for 2008. Vladimir Kryshtal 2008 Circuit Breaker helped pay his taxes. He needs help with 2007. He will pay 2009. Commissioner Urie if we waive the taxes for 2007 is he going to come back next year asking for help again. Vladimir Kryshtal I understand, I believe the taxes for 2010 will be small and am hoping to sell the property. I am just asking for help for 2007 taxes. I will take care of 2010. Gerry Bowden we reduced the property value down to \$1100.00 on the house.
